

How did energy demand change in Ireland in 2023?

Ireland's total energy demand increased by 0.8% in 2023, led mainly by increased energy demand for transport (up 4.5%) and from the commercial services sector (up 6.9%), which includes data centre demand. Increased demand for transport energy came mainly from private car use and aviation, which accounted for 40% and 22% respectively.

Is Ireland's energy transition smooth?

Despite these achievements, Ireland's energy transition is far from smooth. The electricity grid, designed for centralised fossil fuel plants, is struggling to integrate decentralised renewable energy sources. Modernising this infrastructure will be critical to supporting future wind and solar expansion.

How will the 2024 energy year impact Ireland?

This could have several implications for the 2024 energy year in Ireland. Opportunities for renewables growth will need to be consolidated with issues like mandates for energy efficiency and accommodating for large energy users. We need to ensure that short-term challenges do not restrict opportunities for long-term growth.

How much energy does Ireland use per year?

Total annual energy consumption (after adjustments) is projected to be 14,142 ktoe (14.142 million tonnes of oil equivalent) by 2020. To meet Ireland's overall target of 16% use of renewable energy in gross final energy consumption by 2020 (it was just 3.1% in 2005) targets have been set for each sector.

What is the NCV in Ireland's energy balance?

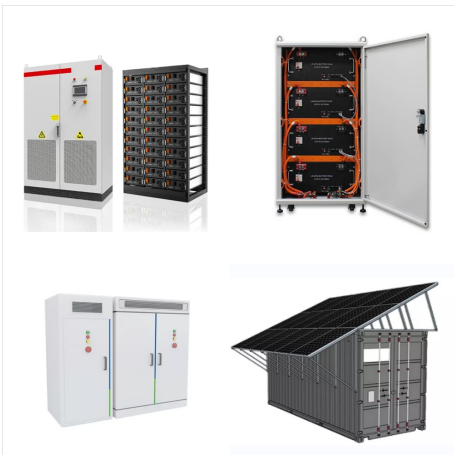
Since the NCV represents the amount of actual usable energy, we adopted NCVs into the methodology for Ireland's Energy Balance. The differences between net and gross calorific values are typically about 5% to 6% of the gross value for solid and liquid fuels, and about 10% for natural gas.

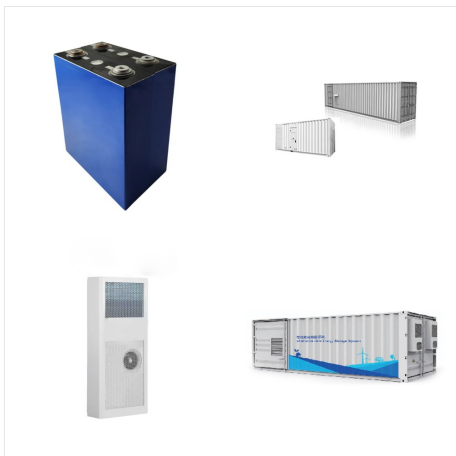

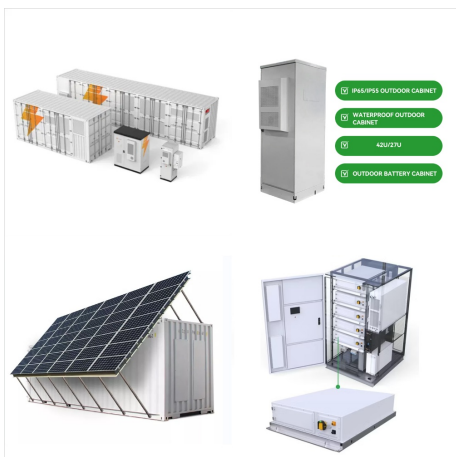

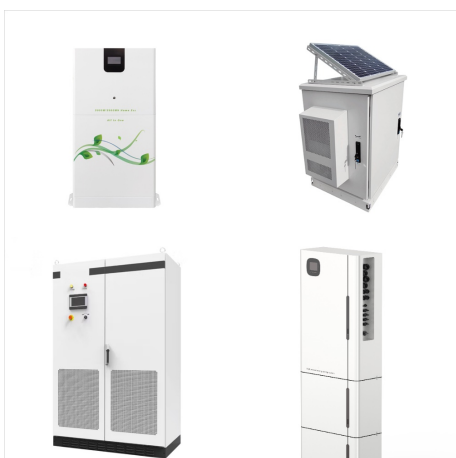
