

The BESS will help address the intermittency issues of renewable energy by storing surplus electricity generated during high production and releasing it during periods of low production. How can a first-mover country achieve 5 GW of Bess commitments?

Through the BESS Consortium, these first-mover countries are part of a collaborative effort to secure 5 gigawatts (GW) of BESS commitments by the end of 2024. In order to achieve the estimated 400 GW of renewable energy needed to alleviate energy poverty by 2030 and save a gigaton of CO2,90 GW of storage capacity must be developed.

What is the Bess consortium?

The BESS Consortium is a multi-stakeholder partnershipset up to ensure these BESS benefits transform energy systems across low- and middle-income countries (LMICs). The Consortium is on track to meet its target of securing 5 GW of BESS commitments by the end of 2024 and deploying these by the end of 2027.

Where is ADB implementing Bess projects?

ADB is implementing BESS projects across Asia and the Pacific, from small-scale projects in the Maldives, Philippines, and Pacific Islands, to large-scale projects in Cambodia, Thailand, and Mongolia.

Why is Bess a critical technology?

BESS is a critical technology to achieve that goal, but progress is being severely hindered by unfavorable policies and regulations, high financing costs, long project lead times, and other challenges.





Infrastructure investor Avadis Investment

Sungrow has announced the signing of an agreement with MSR Green Energy (MSR-GE) to advance a 100MW/400MWh Battery Energy Storage System (BESS) project in Sabah, Malaysia. The project is expected to play a crucial role in the region's transition to renewable energy and sustainable development, with a final installed capacity of 517MWh.





"With Enervest, we share a focus on large-scale and financially attractive projects to enhance grid resiliency, and the Stoney Creek project is another example of executing the growth plans that we have outlined for 2025 and beyond." In May 2024, Energy Vault secured contracts from ACEN Australia to install two large-scale BESS facilities.
