

Is power home solar a deceptive company?

To protect consumers in Pennsylvania, Attorney General Josh Shapiro launched an investigation into Power Home Solar, who also does business as Pink Energy, after receiving complaints regarding the company's alleged deceptive business practices.

Is there hope for homeowners involved with a now-defunct solar panel company?

Did a news 5 investigation close a solar energy company?

CLEVELAND -- A solar energy company that was the focus of a recent News 5 Investigation has closed its doors. You might remember in July, News 5's Jonathan Walsh reported on a hidden camera investigation into Power Home Solar, which changed its name to Pink Energy.

How many complaints does Ohio Ag have against power home solar?

In its complaint, the Ohio AG also claims it has received more than 100 consumer complaints against Power Home Solar (Pink Energy) alleging instances of aggressive sales tactics, misrepresentations of cost savings, and a host of installation and warranty issues.

What happens if a solar power company goes bankrupt?

We've handled claims from other solar power companies as well - generally, if the company went bankrupt, we believe the claims are strong because there almost certainly has been a breach of your contract if it has maintenance provisions or warranty provisions that aren't being followed.

Why did pink energy terminate its solar panels?

And we've terminated those that we found," Pink Energy CEO Jayson Waller told WBTV in an interview. Waller also claimed the issues with panels underdelivering were because of a malfunctioning battery that was supplied by another company for the solar panel projects. Pink Energy filed a lawsuit against that company.

WBTV first reported on Pink Energy, formerly known as Power Home Solar, earlier this month, when the Investigates Team uncovered more than 80 complaints filed with the North Carolina Attorney General against the company. Many customers told WBTV that their solar panels aren't producing the energy or the savings they were originally promised.

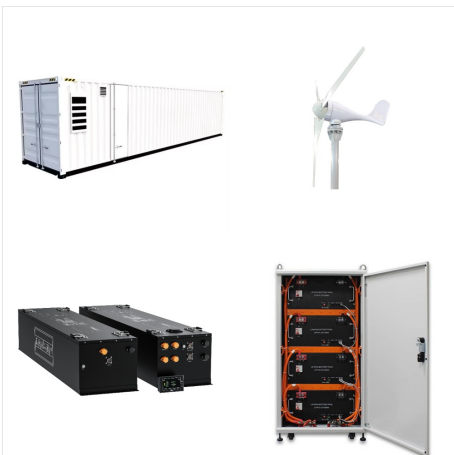

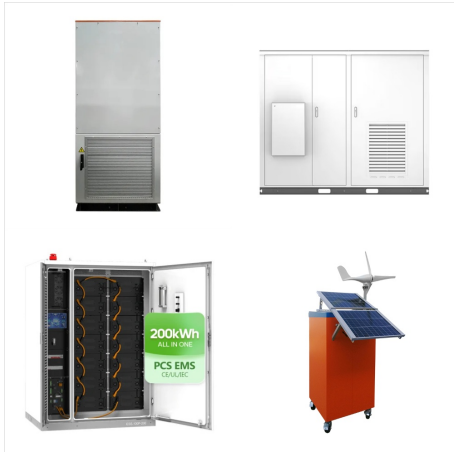

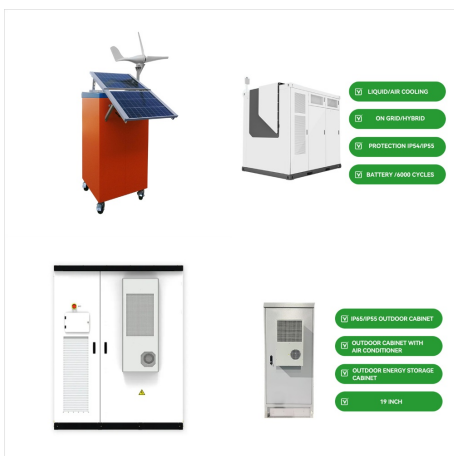

5. Defendant Power Home Solar, LLC is a limited liability corporation with its principal place of business located at 919 N. Main St., Ste. 200, Mooresville, North Carolina 28115-2355. Power Home Solar, LLC does business in Ohio under the fictitious name Pink Energy, which has been registered with the Ohio Secretary of State since January 17



SunPower is a solar power company based in Silicon Valley. The company reportedly holds over 1,000 patents for solar innovation and, according to the company's website, has been the No. 1 ranked commercial solar company since 2017. However, consumers who purchased solar panels from the company may have unknowingly paid for defective products.



For instance, in 2021, a lawsuit was filed by a group of California consumers over defective micro inverters in the solar panels provided by SunPower. SunPower settled in 2022 for \$4.75 million. In North Carolina in 2022 a lawsuit from former employees of Power Home Solar claimed that Power Home unlawfully terminated the employees during a

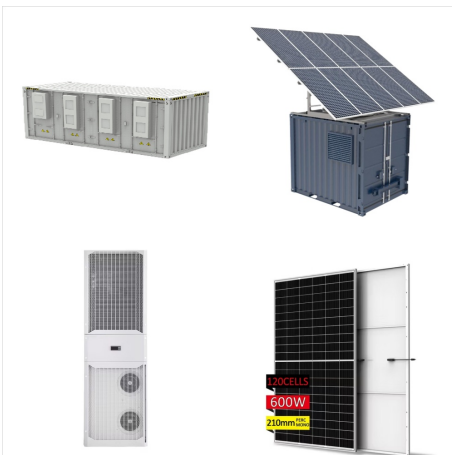
