

The company sells valuable wastes to recycling companies in Vientiane Capital, Thailand, and Vietnam. The landfill is managed by Lao Development and Waste Disposal Co Ltd, who is also responsible for the collection and transport, on a 30-year, renewable contract signed in 2015.

Who is responsible for solid waste management in Lao PDR?

At the same time, current waste management practices are inadequate and cause a variety of environmental, social, and economic impacts. The operational responsibility for solid waste management in Lao PDR lays on the local level, with the city and provincial authorities.

Does Luang Prabang have a solid waste management policy?

Cited in NUOL activity report prepared under Task A and B of this project. There is no provincial legislation or policy specifically on solid waste management. The vision of Luang Prabang is "to become a clean, green and livable in parallel with the sustainable protection of environment and the world heritage".

Who is responsible for waste management in Luang Prabang?

In line with the Local Administration Law (2003), which delegated responsibilities on natural resources and the environment to the provincial and city administrations offices, and further detailed in a Provincial Degree, the responsibility for waste management in Luang Prabang belongs to LPCOS (previously called UDAA or USO).

Does Vientiane have a sustainable solid waste management plan?

Currently, there are no policies or regulations (incentives, penalties, educational programs etc.) in place to support 3R initiatives. However, VCOMS, with assistance from GGGI, is developing a "Sustainable Solid Waste Management Strategy and Action plan for Vientiane 2020-2030", which is expected to be released soon.

Are mechanical and biological treatment & materials recycling facilities feasible in Lao PDR?

Assess feasibility of mechanical and biological treatment (MBT) and materials recycling facilities (MRFs). Due to rapid urbanization and economic development in Lao PDR, solid waste amounts are increasing, and the waste composition is changing with a continuous increase of the plastic waste fraction.
