

#1:Yes,you can ship lithium batteries via USPS. However ...There are currently six types of lithium batteries eligible for shipment,in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Did the postal service change the shipping standards for lithium batteries?

The Postal Service announced these revisions a Federal Register notice titled "Revision to Mailing Standards for Lithium Batteries," which was published on July 26,2017 (82 FR 34712-34715).

Do I need a Dot label to ship lithium batteries?

NO device in box (via Surface Only) Besides the above DOT labels,text markings are required for shipping individual batteries without the equipment. For example,the below box used text-markings besides DOT and shipping labels. How to Ship Lithium Batteries Internationally with USPS?

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Where can I mail lithium batteries?

Customers can mail packages containing lithium batteries installed in electronic devices to their local Post Office for many international destinations, and Army (APO), Fleet (FPO), and Diplomatic Post Office (DPO) locations. For the current regulations regarding the mailability of lithium batteries, please visit your local Post Office.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

The warning labels shown in Exhibit 325.3 a, Exhibit 325.3 b, and Exhibit 325.4 may appear only on mailpieces containing mailable hazardous materials that require use of the label under Postal Service requirements. Division 5.1, 5.2, Class 8 and Class 9 labels are only permitted when used in conjunction with a Limited Quantity air mark. Exhibit

United States Parcel Service (USPS) published a notice in the Federal Register that describes revisions to USPS Publication 52, Hazardous Restricted, and Perishable Mail. These revisions closely align USPS requirements for shipping lithium cells and batteries with those found in both the U.S. D.O.T. and international regulations.



Each lithium metal cell and battery must contain no more than 0.3 gram of lithium content. Each lithium-ion cell/battery must have a watt-hour rating of not more than 2.7 Wh. Mailpieces must not bear markings or labels identifying the contents as lithium batteries. Exhibit 622.5 . International Lithium Battery Mailability



USPS Packaging Instruction 8B Nonspillable Wet Battery. A nonspillable wet battery containing liquid electrolyte is prohibited from mailing unless the battery casing is completely sealed to prevent the liquid corrosive from spilling during handling, as allowed in 348.Nonspillable batteries with UN2800 are prohibited in international mail, but they may be sent as domestic mail via air ???

How to Use Pub 52. USPS Publication 52, commonly known as "Pub 52", is a public document that contains the hazardous materials shipping regulations, restrictions and guidance for both you and Postal Service employees to ensure the safe and successful transport of lithium batteries and other hazardous material.



??? For Domestic Shipments: ??? The United States Postal Service (USPS) does not provide specific labels for lithium batteries for domestic shipments. ??? However, USPS requires that packages containing lithium batteries adhere to specific packaging requirements and be marked with the appropriate Class 9 Label, indicating the presence of hazardous materials.



All shipments containing lithium batteries or cells (standalone, packed with or installed in equipment) must include markings (or a lithium battery handling label) and documentation that indicates: Whether the package contains ???
