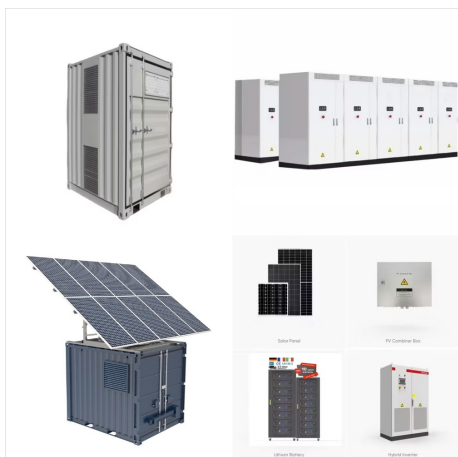

LITHIUM ION BATTERY PACKAGE LABEL



Items must be packaged in accordance with Packing Instructions 967 (Lithium Ion or Rechargeable) or 970 (Lithium Metal or Non-rechargeable). Both Packing Instructions prohibit the use of the "Lithium Battery Handling" label or the "Class 9 Miscellaneous Dangerous Goods" label on the outside of the package for international mailing.

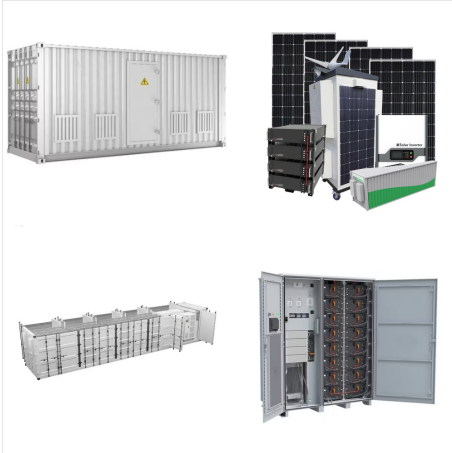

A battery handling label won't be the only type of label that you'll need to place on a package containing lithium batteries. You'll also need to put a class 9 dangerous goods label on it as well. Just like a battery handling label, a class 9 dangerous goods label will need to be 4 inches by 4 inches in size.

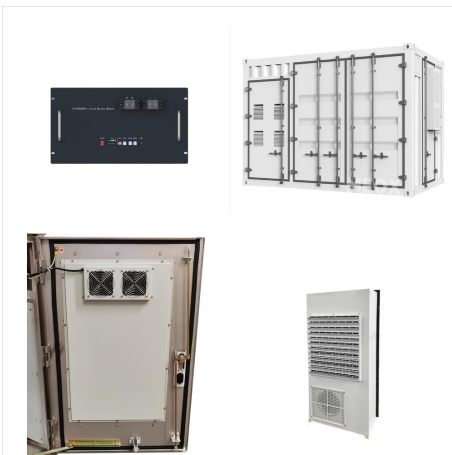

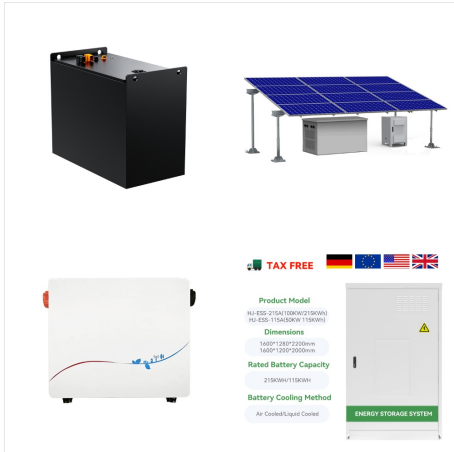

Note: The Lithium Battery Mark cannot be folded or wrapped around multiple sides of the package. UN 3480, Lithium Ion Batteries Sections IA and IB have a state



The telephone number does not need to be monitored 24 hours a day, it can be the normal phone number of the business shipping the battery so long as a person with knowledge of the package can be reached there during normal business hours.
