




SOLAR MARKET DEVELOPMENT TAX CREDIT ??? SB 29 (2020) In the 2020 legislative session, the New Mexico legislature passed SB 29, establishing a new solar market development tax credit. 
### **NEW MEXICO SOLAR ENERGY TAX SOLAR**° CREDIT

The New Mexico New Solar Market Development Tax Credit (NSMDTC) offers tax credits against New Mexico state personal income tax for purchasing and installing solar systems on residences, businesses, and agricultural enterprises in New Mexico. The tax credit provides up to 10% of the purchase and installation costs of a solar thermal or

### A New Mexico property owner may apply for the 2021 Sustainable Building Tax Credit for ECPs from the Energy, Minerals and Natural Resources Department (EMNRD) after the installation of energy conserving products in an existing New Mexico building. Energy Conserving Products (ECP) must meet Energy Star performance values or equivalent

The Renewable Energy Production Tax Credit (REPTC) [NMSA 1978, ? 7-2A-19] has sunset, but created a significant incentive for economic development in New Mexico, attracting utility-scale renewable energy developers to the state and assisting utilities in meeting state Renewable Portfolio Standard (RPS) requirements.
