Released during its third quarter financial results, the figure would more than a doubling of its present renewables and energy storage portfolio, which stood at 38GW as of the end of September.

What happened to NextEra Energy Resources?

In November 2016, NextEra Energy Resources sold two natural gas plants located in Marcus Hook, Pennsylvania and other assets to Starwood Energy Group. The sale totaled approximately \$765 million and included the combined-cycle Marcus Hook Energy Center (790 MW) and the simple-cycle Marcus Hook 50 Energy Center (50 MW).

Between 2024 and 2027, Next Era targets to develop 13.9 GW of solar PV capacity across the US. Image:

US utility giant NextEra Energy added 1.84GW of renewables and energy storage projects to its backlog in Q2 2021, but its Energy Resources division reported a fiscal loss of US\$315 million. Of the 1.84GW NextEra Energy Resources added in the second quarter, roughly 1.45GW was new solar and 105MW was new energy storage.
