Northvolt's troubles are compounded by a series of setbacks, including the loss of a ???2 billion (\$2.1 billion) contract with BMW in June due to production delays. Volkswagen, another key partner, has reportedly refused to increase battery orders, citing commitments to its own battery factories supplied by Belgium's Umicore.





Northvolt's CEO and co-founder Peter Carlsson stepped down on Friday, just a day after the company filed for U.S. Chapter 11 bankruptcy protection, according to a report from Reuters. The move marks a dramatic turn for what was once Europe's leading hope in the electric vehicle battery sector. The news comes as a shock, especially


