years.



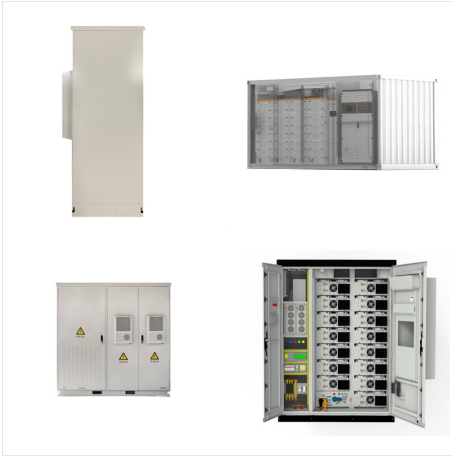

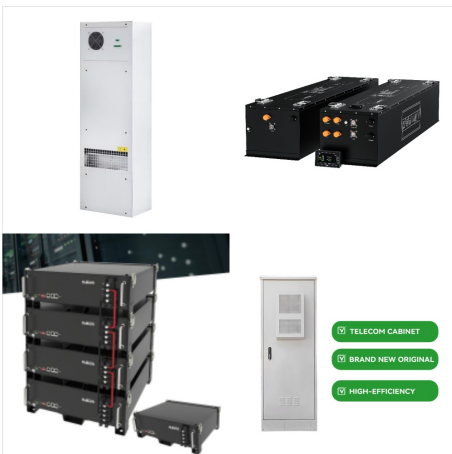
