Will Volvo take full ownership of Novo energy?

In a surprise move, the carmaker on Wednesday announced plans to invoke its redemption rights to take full ownership of the NOVO Energy project as Northvolt has failed to fulfill its financing obligations. "This action follows a breach of the parties' shareholders' agreement," Gothenburg-based Volvo said in a statement.

Could Novo energy be multifunctional?

The NOVO Energy building could be multifunctionaland various options are now being considered on the assumption that Volvo Cars reaches full ownership. Any battery production at NOVO Energy is dependent on third party or other partner involvement.

Will Northvolt AB breach its shareholders' agreement?




