

The Oncor Solar Photovoltaic (PV) Program offers financial incentives for Oncor customers who install eligible distributed solar energy generating equipment.

Does Oncor pay a service provider for a solar photovoltaic system?

Through the program, Oncor pays incentivesto service providers who market, sell/lease and install solar photovoltaic systems to Oncor commercial and residential customers. A service provider's participation in the program does not constitute Oncor's endorsement or approval of any company, product or service.

Does Oncor offer incentives for energy storage systems?

Oncor will continue this trend into the 2024 program year with the aim to follow the market direction and continuously evolve the program. Note, this does not mean there will be incentives offered for Energy Storage systems but rather, Energy Storage systems serve as a mandatory qualifier to obtain residential solar PV incentives.

What are Oncor's solar incentive programs?

Beginning 2024,Oncor's solar incentive programs are two separate programs: The photovoltaic standard offer programfor residential solar projects and the Commercial Solar Option in the Commercial Standard Offer Program for commercial solar projects.

What is the 2024 Oncor solar incentive program?

Welcome to the 2024 Oncor Solar incentive program. The program offers financial incentives for the installation of eligible distributed solar energy generating equipmentand is open to all eligible residential and commercial Oncor customers.

Does Oncor offer a solar investment tax credit?

Unlike the HEE program, which is available for renters, the solar PV program only applies for Oncor customers who own the home where they live. This benefit can be combined with the Solar Investment Tax Credit



(ITC), which was increased to 30% and extended for 10 years by the Inflation Reduction Act (August 2022).



Service providers must follow the following process in order to participate in this program: Customers work with service providers to determine eligibility and define the technical specifications of a solar electric system suitable for their property.

The Commercial Standard Offer Program encourages service providers to offer energy efficiency products and services to the private sector therefore reducing energy consumption for non-residential customers in the Oncor service area.




Oncor's Residential Solar Program encourages homeowners within its service area to adopt solar technology by offering incentives for installing photovoltaic systems with energy storage backup. This initiative helps offset the upfront costs, making solar more accessible and providing a quicker return on investment.



The Low-Income Weatherization Standard Offer Program (LIW SOP) is designed to help improve energy efficiency in the homes of Oncor residential customers with an annual household income at or below 200% of the federal poverty guidelines. The program's primary objective is to achieve cost-effective reduction in electric demand.





Some retail electric providers offer buy-back plans for surplus generation sent to the grid. Customers should compare plans carefully to maximize their savings on electric usage. Oncor has a solar photovoltaic program that helps customers find service providers, and offers incentives that may offset initial costs.



The Solar Photovoltaic Standard Offer Program (SPVSOP) is available for both homes and businesses in the Oncor service area. The total budget for 2023 is \$3,390,000, which is divided as follows: \$2,040,000 for commercial solar power.
