



How does CEC work in Zambia?

Copperbelt Energy Corporation (CEC) transports power from one point on the national grid to another using the CEC transmission and distribution network. This service is primarily provided to Zambia's national electric utility, ZESCO. CEC has developed a 1MW Photovoltaic (or 'PV') solar plant on the Copperbelt that generates clean, reliable energy.

What is a solar power plant in Zambia?

A solar power plant in Zambia, specifically the Riverside Solar Power Project, is a 1MW Photovoltaic (PV) solar plant developed by Copperbelt Energy Corporation (CEC). It generates clean, reliable energy and was Zambia's first grid-connected solar power plant when it was commissioned in April 2018.

What is the Kabompo hydro power project?

The Kabompo hydro power project is a 40MW hydroelectric power generation scheme located in Mwinilunga District of North-Western Province. It is the forerunner of Copperbelt Energy Corporation Plc and has an annual energy output of about 166 GWh.

Where is Zambia's first grid-connected solar power plant located?

Zambia's first grid-connected solar power plant is located at the Riverside Solar Power Project, which is near Copperbelt University in Kitwe. The plant occupies an area of 1.1 hectares and uses 3,864 modules rated at 270W each when it was commissioned in April 2018.

What is the Zambia-DRC interconnector?

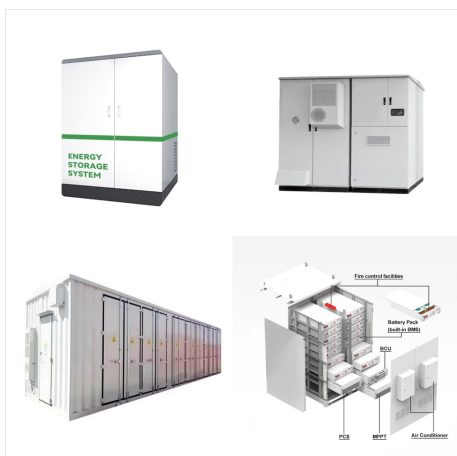
The Zambia-DRC interconnector is the only transmission link between the DRC and Southern Africa. It is used by utilities south of the DRC to move power in either direction. The CEC transmission and distribution network is used to transport power from one point on the national grid to another.

Who owns the Zambia - DRC 220kV interconnector line?

CEC owns the Zambian portion of the Zambia - DRC 220kV interconnector line which has a capacity of 250MW and supplies electricity to mining customers in the Katanga Province. The interconnector is expected to be upgraded to a dual circuit with a capacity of 550MW by the end of 2015. [needs update]

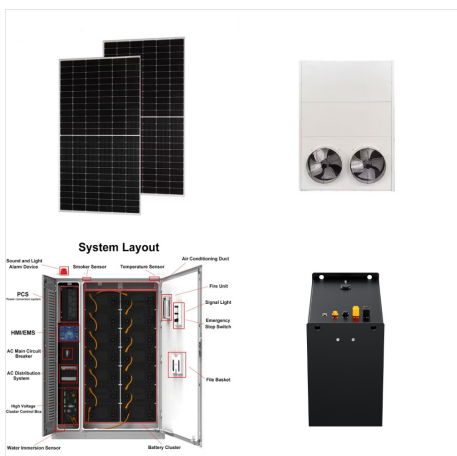

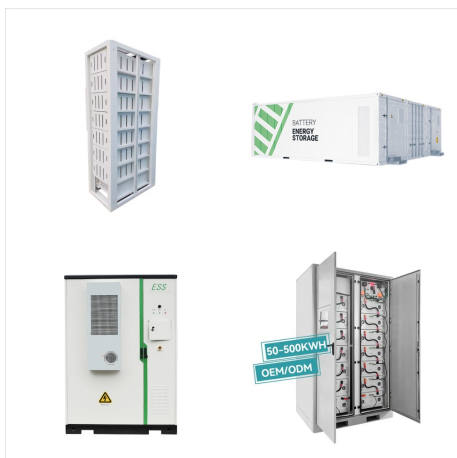

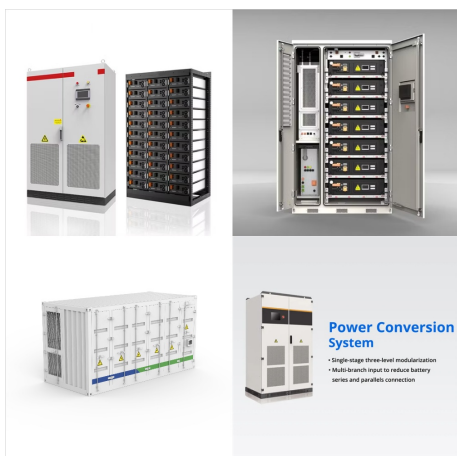
