

How many hectares will be allocated to Rajasthan solar park development company?

According to the proposal, 4,780 hectares have been allotted to Rajasthan Solar Park Development Company to set up three solar parks of 2,450 MW in Bikaner district and about 910 hectares to NTPC Renewable Energy Ltd to set up a solar project of 500 MW in Phalodi district.

Where is Rajasthan solar park located?

Spread across more than 14,000 acres, the park is located at Bhadla village in the Jodhpur district in Rajasthan. The solar park has been developed by multiple entities. Rajasthan Renewable Energy Corporation Limited (RRECL), through its subsidiary, Rajasthan Solar Park Development Company Limited (RSPDCL), has constructed 745 MW of projects.

Who is developing solar park in Jaisalmer & Bikaner?

Agarwal said the ministry of new and renewable energy of the central government has issued approval to develop the 800MW solar park in Jaisalmer through Rajasthan Power Generation Corporation and 1,000MW solar park in Bikaner through Rajasthan Solar Park Development Company, a subsidiary of Rajasthan Renewable Energy Corporation.

Will Rajasthan be a leader in solar energy?

How many solar parks will be set up in Bikaner district?

Two solar parks of 1,000 MW each and one of 450 MW will be set up in Bikaner district. Approval has been given for allotment of about 1,881 hectares in village Surasar of Pugal tehsil for the first solar park, as per the statement.

How many MW will Fatehgarh solar power park generate?

The proposed 500 MW Solar Park will be developed as two blocks (North & South). The North block will have a total capacity of 300 MW while South block will generate the remaining 200 MW of capacity. A transmission
