What is fusion energy?

This is the amount of carbon dioxide (CO2) released annually into the atmosphere from energy combustion (including flaring) and industrial processes, accelerating climate change. How does Realta fusion generator work?

How does Realta's fusion generator work? Realta's approach uses magnetic mirrorsto channel two abundant fuels -- deuterium, a form of hydrogen extracted from water, and tritium, which can be extracted from lithium -- into a central chamber where it is heated up to extremely high temperatures.

Fusion might be a risky source of power, but as Realta is showing, it's also flexible, providing not just electricity but also heat and neutrons, which are widely used to produce isotopes for medical use.


