How do I register a sole trader business name?

To register with a sole trader business name, you'll need to choose a name that's not already in use. You can use a company name availability checker to make sure. You can't add 'limited' or 'LLP' to the name, and you should avoid using sensitive or misleading words or expressions in the name.

Sole trader names. When you register as a sole trader you will be asked what name you intend to use. This does not mean that you are registering or protecting that name. HMRC want to know what you will be calling your business so they can track it and make sure you are paying enough tax. They keep this information private.

One of the biggest advantages of registering a company name is that running your business as a limited company can help you to legitimately pay less personal tax than being a sole trader. Limited company profits are subject to UK corporation tax, which is currently set at 19 per cent compared to personal tax rates of 20pc-45%.

A business name is a distinct trading appellation and the officially registered name of a sole trader business or a limited company. Both legal and branding considerations make the registration of a company name a key step, and it is typically done through the Companies House register in the UK.

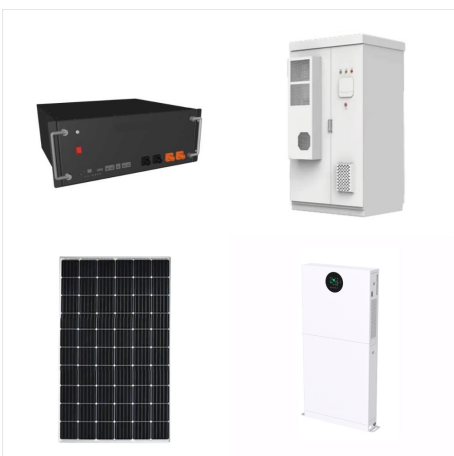

There is no official register of Sole Trader business names in the UK. There are only two ways to register a business name in the UK. These are to form a limited company or get a trade mark. However the majority of businesses in the UK (62.7%) register as Sole Traders. This makes it difficult, but not impossible, to avoid conflicts between



Sole traders typically consider themselves self-employed. In contrast to limited company owners, there is no legal distinction between the owner and the business by UK law. This means that as a sole trader, you are personally responsible for: Any business bills or losses (i.e. you could lose personal assets if things go downhill)

There is no official way to register Sole Trader business names in the UK. You don't have to register your sole trader business name so you can choose the name you want and start trading. 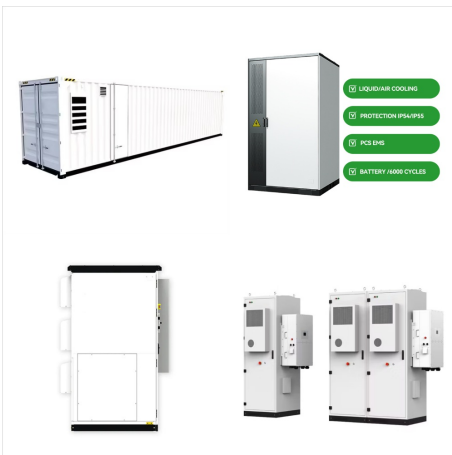

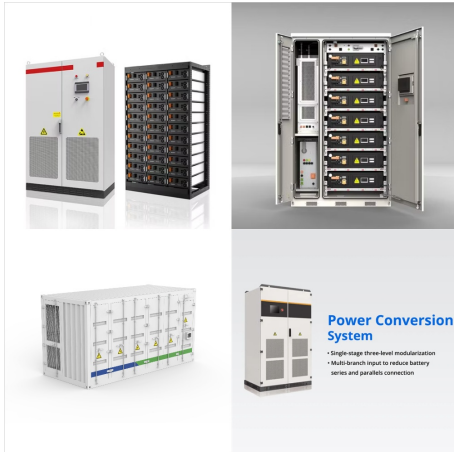


Registering as a Sole Trader. You would need to register for Self Assessment and then file a tax return. So, you must register a business as a sole trader with HMRC if you (any): Earned more than ?1,000 from self-employment in the current financial tax year (from the 6th of April to the following 5th of April).



Where the proposed business name will include a sensitive word, e.g., "accredited," then permission must be granted by the Department for Business and Trade (DBT). (2) Registration of a sole-trader business. Registration of a sole-trader business is complete once the owner registers with the HMRC.

For those who want to work as self-employed and start a low risk business (without a bank loan, expensive lease, etc.); For those who earn more than ?1,000 per year from their hobby or part time business.; Anyone can register as a sole trader regardless of their employment status (unemployed, employed part time or employed full time).



However, sole traders do have the option to set up a limited company (to stop anyone else from forming a limited company with their business name) and then never trade with that company. This is enabled by the fact that once a company has been formed, you are under no obligation to start trading with it.
