Renewable Energy Guarantees of Origin (REGOs) are transferable certificates which One REGO is issued per kWh of renewable electricity generated. REGOs are rounded up or down to the nearest whole kWh. REGOs have a unique reference number representing the generating station, technology and country of origin. The REGO also states the period over

This green certificate is called a Renewable Energy Guarantee of Origin (REGO for short). When an energy supplier buys this renewable power from the generator (to sell on to customers), it buys REGOs simultaneously for around 15p per certificate. Every year, the energy suppliers must send their REGOs to Ofgem.



The Renewable Energy Directive 2018 ((EU) 2018/2001) requires EU member states to provide a Guarantees of Origin (GOO) scheme to certify production of electricity, heating and cooling from eligible renewable energy. In Great Britain, the equivalent scheme was called the REGO scheme.



What is the Renewable Energy Guarantees of Origin (REGO) scheme and why am I applying for it? REGO certificates provide certification that energy being supplied has been generated from a renewable source. We issue one REGO certificate per megawatt hour (MWh) of eligible renewable output to generators of renewable electricity. REGOs are
