“Reliance New Energy Solar (RNE SL), a wholly-owned subsidiary of Reliance Industries (RIL), has announced acquisition of 100 percent shareholding of REC Solar Holdings AS (REC Group) from China National Bluestar (Group), for an Enterprise Value of USD 771 million,” Reliance Industries said in a BSE filing.

Did Reliance Industries buy REC Solar?

Reliance Industries also announced a \$771 million buyout of Norway-based solar panel manufacturer REC Solar Holdings. RNE SL acquired “100 per cent shareholding of REC Solar Holdings AS (REC Group) from China National Bluestar (Group) Co Ltd for an Enterprise Value of USD 771 million (about INR 5,800 crore),” the firm said in a statement.

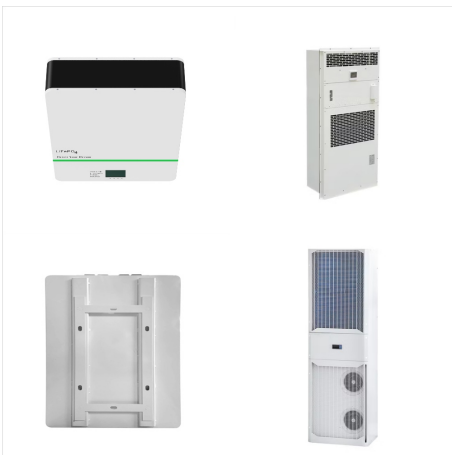

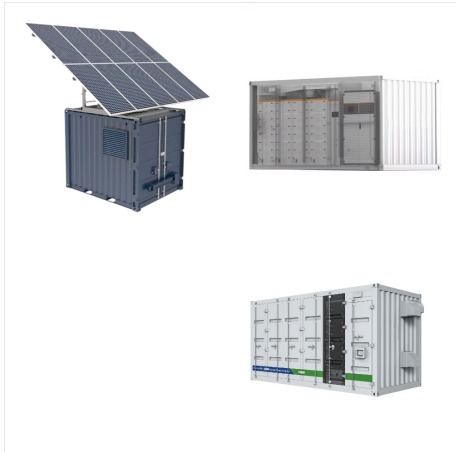
