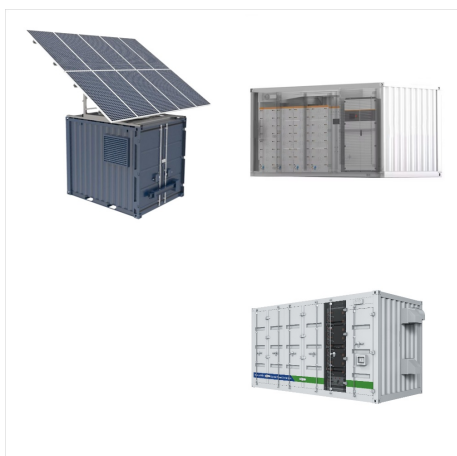
RWE AG is one of the leading European energy groups. Net sales break down by activity as follows:
