


According to the statement, Scatec will now commence construction of the two solar plants, having secured 20-year power purchase agreements (PPAs) with Tunisian state-owned utility STEG in 2019. Aeolus has acquired a 49 per cent stake in the projects, while Scatec retains a 51 per cent majority stake.





During the development phase Scatec and the DF will each fund 50% of the development costs. CI1 and Scatec have agreed to look at developing further wind assets in Tunisia, which include 2-3 other wind assets under development with a total capacity of >300 MW . Our Development Partner . Scatec.

The project is part of the 1.8 GW Benban solar park, one of the world's biggest solar parks where Scatec Solar is the largest developer. In April 2017, Scatec Solar and partners KLP Norfund and Africa 50 signed a 25-year Power Purchase Agreement (PPA) with the Government of Egypt for delivery of electricity from six solar plants, totaling 390 MW.

The Norwegian company Scatec Solar has just concluded a Power Purchase Agreement (PPA) with the Tunisian State. The contract covers the construction and operation of three solar power plants with a cumulative capacity of 360 megawatts (MW). This energy will make it possible to connect 300,000 homes and thus reduce CO2 emissions due to fossil fuels.
