How much oil does SEPLAT produce a day?

SEPLAT subsequently grew oil production to a peak rate of 85,200 barrels (13,550 m<sup>3</sup>) of oil per day and had almost doubled its remaining reserves at the end of 2015. In June 2013, SEPLAT acquired an interest in the Umuseti/Igbuku marginal field area within OPL 283 and in February 2015 acquired interests in OML 53 and OML 55.



The Seplat Energy CEO, whilst delivering the independent Keynote during the AOW Gas Forum themed "Enhancing Africa's Gas Capacity", stated that gas will provide baseload power to facilitate growth in renewable energy which is still a relatively small proportion of the energy mix in Africa.



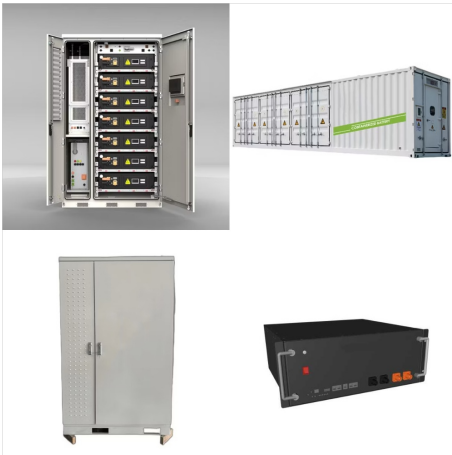

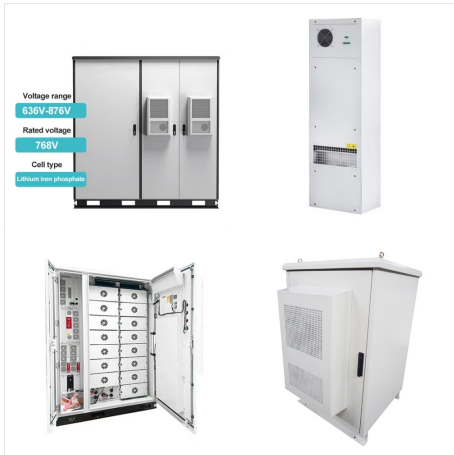
In June 2013, Newton Energy, a wholly owned subsidiary of Seplat, reached an agreement with Pillar Oil to acquire a 40% participating interest (non-operated) in the Umuseti/Igbuku fields (OPL 283). In 2015, the Group purchased a 40% participating interest in OML 53, onshore north eastern Niger Delta, from Chevron Nigeria Ltd and a revenue interest in OML 55, south eastern Niger ???

In 2023, Seplat Energy PLC increased its cash reserves by 11.32%, or 45.77m. The company earned 445.07m from its operations for a Cash Flow Margin of 41.94%. In addition the company used 162.40m on investing activities and also paid 196.66m in financing cash flows.
