



Can I ship lithium batteries via the USPS?

Either of these solutions will help you continue to ship lithium battery devices via the USPS in full compliance with the new rules. For a more complete explanation of the Postal Service's rules for shipping lithium batteries, please visit our USPS Publication 52 page.

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Where can I mail lithium batteries?

Customers can mail packages containing lithium batteries installed in electronic devices to their local Post Office for many international destinations, and Army (APO), Fleet (FPO), and Diplomatic Post Office (DPO) locations. For the current regulations regarding the mailability of lithium batteries, please visit your local Post Office.

Can a cell battery be mailed?

Devices such as cellphones, watches, and vape with a single cell over 20Wh per cell cannot be mailed. Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable.

Damaged/recalled individual batteries are prohibited and need approval.

USPS Lithium Battery Shipping Regulations for Cell Phones. Now that we understand the "why" behind the rules, let's cover what you need to know to comply with USPS regulations. According to the USPS website, you CAN ship a cell phone with a lithium-ion battery already installed. However, there are limits on the battery's Watt-hour (Wh

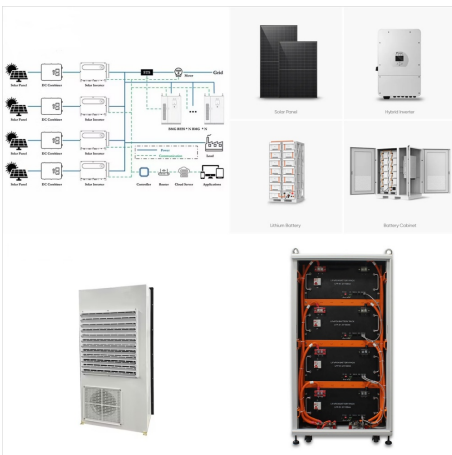

SHIPPING CELL PHONES WITH LITHIUM BATTERIES USPS



Lithium batteries are used in many electronic devices such as cameras, cell phones, laptop computers, medical equipment and power tools. To ship or import lithium batteries, including those contained in or packed with devices and equipment, you must: declare the batteries to postal carriers, couriers or transport companies as part of the contents



Lithium metal (non-rechargeable batteries used to power calculators, remote car locks etc.) and lithium ion batteries (rechargeable batteries used to power laptops, cell phones, camcorders etc.) will be classified under separate shipping descriptions.



Persons wishing to ship lithium batteries and electronic devices containing lithium batteries by mail should be aware and cell phones???safely and easily if certain precautions are taken. Here are some things to remember: 1. All batteries need to be protected against: For shipments made using carriers other than the United States Postal

United States Parcel Service (USPS) published a notice in the Federal Register that describes revisions to USPS Publication 52, Hazardous Restricted, and Perishable Mail. These revisions closely align USPS requirements for shipping lithium cells and batteries with those found in both the U.S. D.O.T. and international regulations.

Shipping a cell phone through USPS may seem daunting, but with the right preparation and knowledge, it can be a smooth process. USPS offers several shipping options for cell phones, including Priority Mail, First-Class Mail, and Priority Mail Express. If your cell phone has a lithium-ion battery, it is important to follow certain guidelines



Since it's not practical to calculate the weight of each battery in every device being shipped, we recommend using an estimate of 25% for phones and 40% for tablets - the idea being that each phone's battery is 25% of the phone's weight. At 25%, you can ship up to 20kgs/44lbs of phones without needing a Cargo Aircraft Only sticker. Having a

Lithium metal (non-rechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities internationally or to and from APO, FPO, or DPO locations only when they are properly installed in the equipment they operate.

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

Except for mailpieces containing button cell batteries installed in equipment (including circuit boards), or no more than 4 lithium-ion cells or 2 lithium-ion batteries installed in the equipment they operate, mailpieces containing lithium-ion batteries must bear a DOT-approved lithium battery mark, as specified in 49 CFR 173.185(c)(3)(i) and

LITHIUM BATTERIES. Lithium batteries power numerous electronics from cell phones, laptops, and tablets to wireless headphones, toys, and portable tools. What is not generally known is that these batteries are considered hazardous materials and remain highly regulated in transportation.



Almost all rechargeable devices, from cell phones to power tools, contain lithium batteries and may require that you declare the package contains hazardous materials when shipping your item. When shipping with USPS, these items can only be sent via Ground Advantage.



US POSTAL SERVICE 475 L" ENFANT PLZ SW RM 4446 Small consumer-type lithium-ion cells and batteries like those used to power cell phones and laptop computers are mailable in a single shipment with the following restrictions: Each lithium-ion or lithium polymer cell or battery must not exceed a watt-hour rating of 2.7 Wh.

Mailpieces containing only button-cell batteries installed in equipment, or no more than four lithium cells or two lithium batteries installed in equipment they operate, (i.e., cell phones, tablets, digital readers, or glucose monitors, etc.) are not required to bear the lithium-battery mark, domestically, when no more than two mailpieces are
