

Can a lithium battery be mailed internationally?

2. Used, damaged, defective, or recalled lithium batteries and used damaged, or defective electronic devices containing lithium batteries are prohibited and may not be mailed internationally or to, from or between APO, FPO, or DPO locations under any circumstances.

Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Can batteries be mailed internationally?

Damaged or recalled batteries are prohibited and may not be mailed internationally under any circumstances. Small consumer-type primary lithium cells and batteries (lithium metal or lithium alloy) like those used to power cameras and flashlights are mailable in a single shipment with the following restrictions: a.

Can a battery be shipped via USPS?

USPS battery shipping allows you to ship it under certain conditions, but there are still some types of batteries that cannot be shipped. The following introduces nonmailable and mailable situations: USPS has strict rules for shipping batteries, and one of the most critical factors is Watt hours (Wh).

Where can I mail lithium batteries?

Customers can mail packages containing lithium batteries installed in electronic devices to their local Post Office for many international destinations, and Army (APO), Fleet (FPO), and Diplomatic Post Office (DPO) locations. 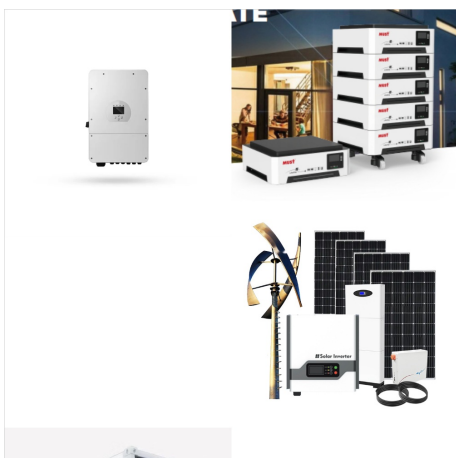

How to safely ship lithium-ion and other batteries internationally including understanding restrictions, prohibitions and suitable packaging. When you are shipping your personal effects and household goods overseas it is quite likely that you'll also need to send some items with batteries.



To ship or import lithium batteries, including those contained in or packed with devices and equipment, you must: declare the batteries to postal carriers, couriers or transport companies as part of the contents; When shipping or importing lithium batteries internationally by aircraft, Part 12 of the TDG Regulations requires you to comply

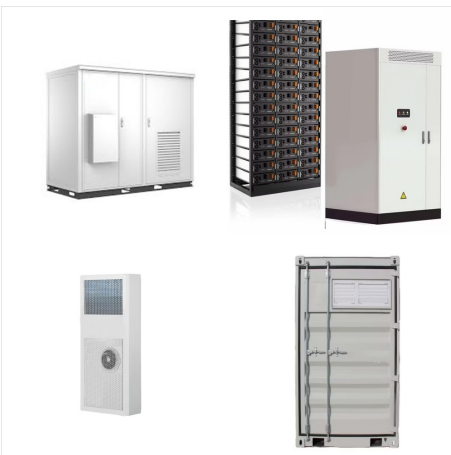

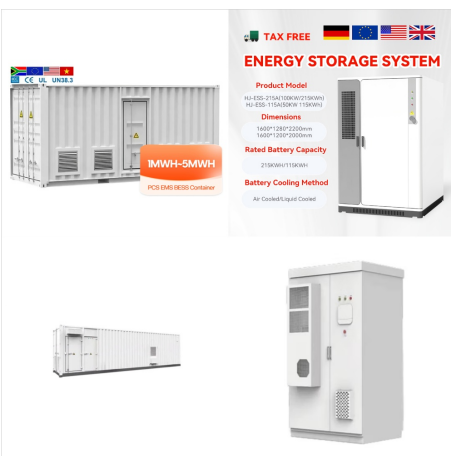

USPS implemented its ban on the shipment of lithium batteries internationally back in May 2012, just days before the UPU and ICAO adopted their rule change to allow lithium battery shipping. In the UK, Royal Mail said last week that it is currently implementing updated rules that should allow lithium batteries to be sent within outbound

Like lithium batteries, there are strict regulations to follow when shipping wet batteries internationally. An IATA Dangerous Goods label must be attached, along with the correct UN number and shipping name for the particular type of batteries. You must also complete a Dangerous Goods Shipper's Declaration, detailing the contents and potential
