

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check [here](#).

Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Can You ship a battery across a country?

Many electronic products and devices contain batteries - in particular, lithium batteries, which are commonly found in laptops, smartphones, tablets, medical devices and power tools. There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Can I ship a recalled lithium battery?

Don't forget the new lithium battery marks that became mandatory this year! However--you knew that was coming, right?-- you cannot ship fully regulated or the damaged or recalled versions of these batteries via U.S.




Ground shipments of lithium batteries do not incur Dangerous Goods fees. OSI cannot ship lithium batteries via Ground service to Alaska to Hawaii. Please select 2 Day or Priority Overnight for shipments of lithium batteries to Alaska and Hawaii. Certain countries restrict international shipping of lithium batteries.

While UN Model Regulations set the foundation for lithium battery shipping globally, individual countries and regions often have additional and potentially stricter regulations in place. Here are some specific examples of regional restrictions for shipping lithium polymer batteries: Some restrictions might apply for Alaska, Hawaii, Puerto



Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).



Why are Lithium Batteries Regulated in Transportation? The risks posed by lithium cells and batteries are generally a function of type, size, and chemistry. Whether shipping a single battery, a palletized load of batteries, or a battery-powered device, the safety of the package, and those who handle it along its journey, depends on

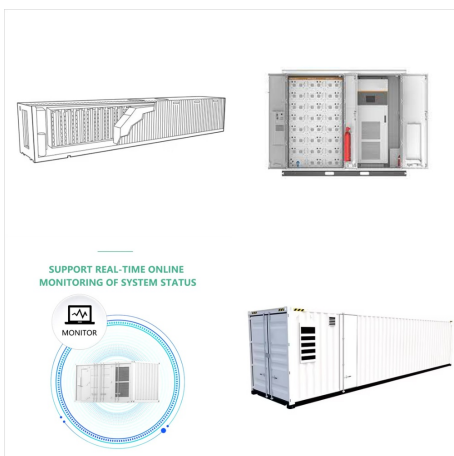

Any package bearing a lithium battery shipping label should also be marked as dangerous goods and have the necessary documentation; It may be necessary to use specialized packaging to ensure the safety; Lithium Metal Batteries These are batteries that use lithium as an anode. They have a long life and can produce anywhere between 1.5V-3.7V.








Effective July 1, 2015, all existing customers and

batteries without equipment (UN3090) via UPS (R)
Air services must obtain pre-approval from UPS
Airlines. This requirement is to ensure that proper
training has occurred and that all applicable safety
regulations are properly followed for such
shipments.
