



How does FedEx handle lithium battery shipments?

At FedEx, we have a robust system in place to mitigate risks with lithium battery shipments. We support the harmonization of US law with the International Civil Aviation Organization rules for lithium batteries. A global set of rules should be applicable to this inherently global product.

How many lithium ion batteries can a FedEx Express ship?

Lithium battery shipping regulations include strict quantity limits, especially for air transport. The limits vary based on battery type, configuration, and Watt-hour (Wh) rating. Here are a few key quantity rules for FedEx Express: Standalone lithium ion batteries are limited to 35kg per package for cargo aircraft.

Can You ship lithium batteries to Hawaii?

If you've lived in Hawaii for any length of time, you know that shipping items to the state can present some challenges. Some stores don't ship to Hawaii, while others tack on exorbitant fees. Still others are willing to ship to Hawaii--but exclude certain items. What kind of solutions are available for shipping lithium batteries to Hawaii?

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

What is a bill of lading for lithium battery shipments to Hawaii?

For lithium battery shipments to Hawaii, the bill of lading must clearly identify the batteries and quantity, and indicate they are fully regulated Class 9 hazardous materials. The document helps ensure all cargo handlers are aware of the shipment contents and any risks.

Can a lithium battery be shipped alone?

You can still ship stand-alone lithium batteries if they comply with either Section IA or IB of the IATA Dangerous Goods Regulations (DGR) packing instructions 965 and 968, which are fully regulated dangerous goods shipments that require the Shipper's Declaration for Dangerous Goods be completed and signed by a

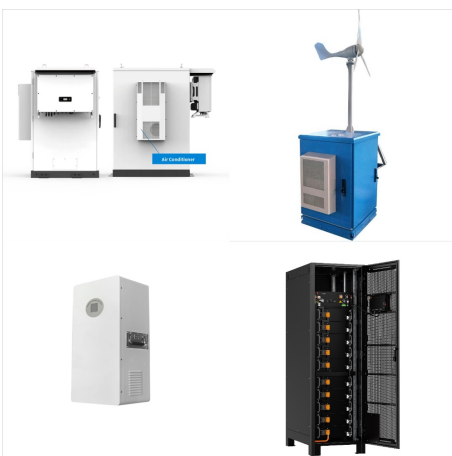

OSI Batteries will ship using FedEx, DHL, UPS, Expeditors, Old Dominion, Yellow and most other LTL carriers. OSI cannot ship lithium batteries via Ground service to Alaska to Hawaii. Please select 2 Day or Priority Overnight for shipments of lithium batteries to Alaska and Hawaii.



Due to the complex nature of shipping lithium batteries, it is strongly recommended that shippers take a specific lithium battery transportation course in addition to general hazardous material training. Additional restrictions may apply for FedEx Ground lithium-battery shipments between the contiguous U.S. and Alaska and Hawaii.

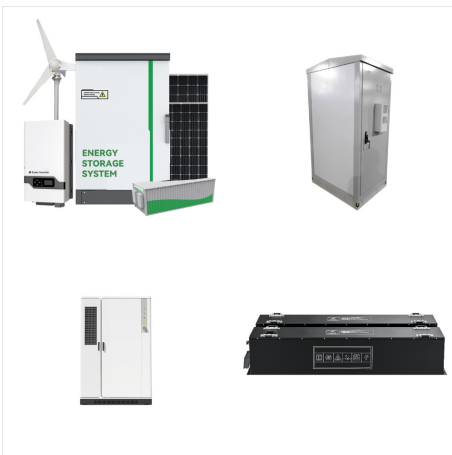

The reason batteries are allowed to be shipped via 2nd-day air or next-day air to Hawaii is because those class of services allow packages to be shipped on cargo-only aircraft compared to ground service to Hawaii where packages are subject to passenger aircraft regulations regarding lithium ion batteries.
