

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Can You ship lithium batteries to Hawaii?

If you've lived in Hawaii for any length of time, you know that shipping items to the state can present some challenges. Some stores don't ship to Hawaii, while others tack on exorbitant fees. Still others are willing to ship to Hawaii--but exclude certain items. What kind of solutions are available for shipping lithium batteries to Hawaii?

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check [here](#).

What is a bill of lading for lithium battery shipments to Hawaii?

For lithium battery shipments to Hawaii, the bill of lading must clearly identify the batteries and quantity, and indicate they are fully regulated Class 9 hazardous materials. The document helps ensure all cargo handlers are aware of the shipment contents and any risks.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Do I need a lithium battery approval before shipping?

UPS requires all lithium metal battery air shippers to be approved prior to shipping. Please review the requirements for lithium metal battery approval: Lithium ion (Li-ion) batteries are rechargeable. Lithium metal

Any package bearing a lithium battery shipping label should also be marked as dangerous goods and have the necessary documentation; It may be necessary to use specialized packaging to ensure the safety; Lithium Metal Batteries These are batteries that use lithium as an anode. They have a long life and can produce anywhere between 1.5V-3.7V.



Effective 1 July 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS (R) Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.

Shipping Lithium Batteries. Open or Close content below Live Animals. Except in limited circumstances, pets and warm-blooded animals may not go in the mail. Shipments of live animals, including poultry, reptiles, and bees, have very specific packaging requirements.

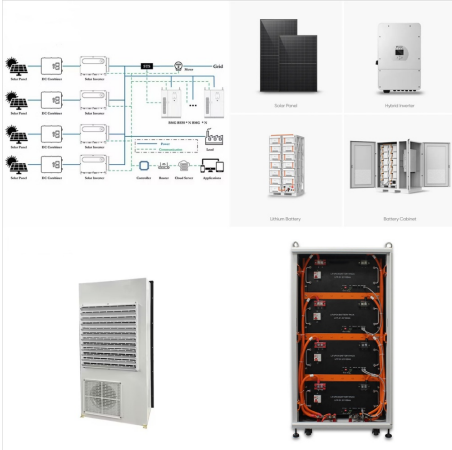

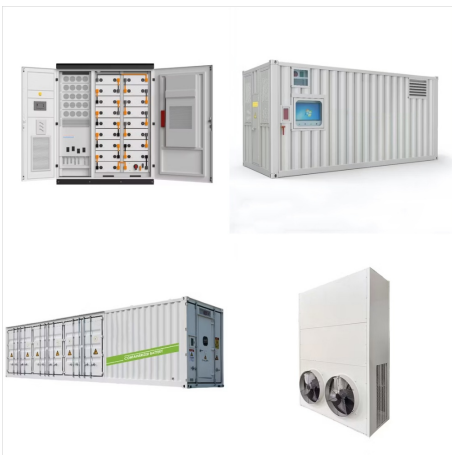

USPS Packaging Instruction 9D Lithium Metal and Lithium-ion Cells and Batteries ??? Domestic. Except according to 349.21, lithium metal (nonrechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities domestically via air or surface transportation when they are installed in or packed with the equipment they are intended to ???

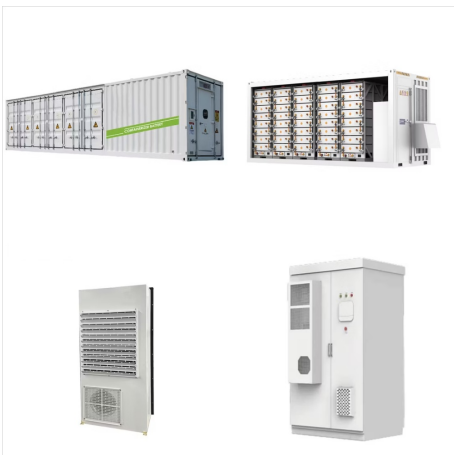


The lithium batteries must be of a type that have successfully passed the UN38.3 tests and contain the necessary systems to prevent overcharge and over discharge between the batteries.

Shipping costs for Dakota Lithium batteries are calculated per battery due to their classification as hazardous materials (hazmat), ensuring safe and compliant handling and transportation. Shipping costs to Alaska and Hawaii may be higher due to federal law that requires that batteries ship Air Freight and have Hazmat protection.



Living in Hawaii I have received a ton of "ground" shipments like USPS Ground Advantage, UPS Ground, a lot of which shipped very fast (I'm not in a hurry). Would it be possible to ship large lithium batteries by ground shipping to Hawaii?



To assist shippers of lithium batteries, including equipment with installed lithium batteries, a requirement came into force with effect January 1, 2019 that manufacturers and subsequent distributors of lithium cells and batteries must make available a test summary that provides evidence that the cell or battery type has met the requirements of

Ground shipments of lithium batteries do not incur Dangerous Goods fees. OSI cannot ship lithium batteries via Ground service to Alaska to Hawaii. Please select 2 Day or Priority Overnight for shipments of lithium batteries to Alaska and Hawaii. Certain countries restrict international shipping of lithium batteries.



Shipped out of USA. When shipping papers (Bill of lading forms, Dangerous Goods Declaration forms) are required, all lithium battery shipments to, from or through the United States must have written emergency response information accompany the shipment.



Lithium batteries (UN3090, UN3091, UN3480, UN3481) Regulatory Changes Please note that regulations applicable to lithium batteries are dynamic. Please note that domestic transportation requirements for lithium batteries include Alaska and Hawaii, but do not include Army, Fleet and Diplomatic Post Offices (APO, FPO, DPO), which are covered under international shipping requirements.
