Who owns Skyborn Renewables?

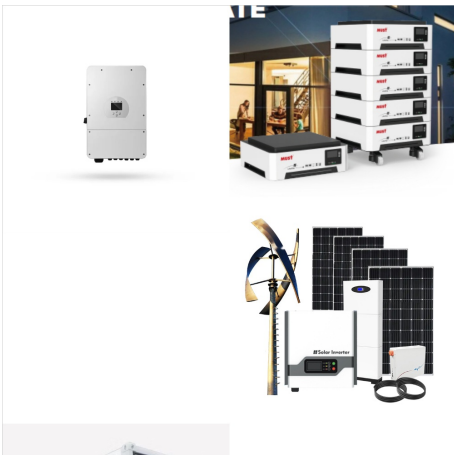
Skyborn Renewables was the former offshore wind business of German renewables developer Wpd AG. It was acquired by US private equity firm Global Infrastructure Partners (GIP) earlier this year. The statement published on Wednesday did not disclose the size of the shareholding bought by Mubadala or the amount of the investment.
