How SMEs can access finance in El Salvador?

In just more than two and a half years, the program significantly increased SMEs' access to finance in El Salvador. With USAID support, the program's financial institution partners: Introduced 36 new or improved SME products. According to a recent Central Bank study, only 18 percent, or fewer than 3,000 SMEs, had access to bank credit in 2005.

How many SMEs are there in El Salvador?

As census estimates put the number of SMEs in El Salvador at 16,000in 2005, an increase of more than 5,200 new SME borrowers represents a significant impact on the number of SMEs with increased access to financial services. See Table 3 for the number of new borrowers in each institution disaggregated by business size and by gender of the borrower.

Who is cofinancing El Salvador's Micro-Small Business Loan program?


