Will Biden's solar law help a solar company reap billions?

One of President Joe Biden's signature laws aimed to invigorate renewable energy manufacturing in the U.S. It will also help a solar panel company reap billions of dollars.

Will Biden levy new penalties on solar panels?

The new trade petitions filed Wednesday ask the Biden administration to levy new penalties on solar components from those countries -- a prospect likely to spark uncertainty at a time when U.S. solar installations are soaring, thanks in part to Democrats' climate law.

Who's ready for the solar industry?

One of the largest players in the solar industry was ready. Executives, officials and major investors in First Solar, the largest domestic maker of solar panels, donated at least \$2 million to Democrats in 2020, including \$1.5 million to Biden's successful bid for the White House.

What is the American Alliance for solar manufacturing trade committee?

Details: A new coalition of U.S. solar manufacturers-- dubbed the American Alliance for Solar Manufacturing Trade Committee -- filed a set of petitions on Wednesday with the U.S. International Trade Commission and the Commerce Department that alleges potentially illegal practices from manufacturers in Malaysia, Cambodia, Thailand and Vietnam.

Who are the 7 domestic solar manufacturers?

The seven domestic solar manufacturers that comprise the coalition are First Solar, Qcells, Meyer Burger, Mission Solar, REC Silicon, Conval Energy and Swift Solar. They allege that record levels of imports

from the four countries are causing prices to collapse and threatening the existence of the emerging domestic solar manufacturing industry.



Last year, a single company filed anti-circumvention petitions with the Department of Commerce (Commerce). The threat of duties ranging from 50 percent to 250 percent on solar panels and cells from Malaysia, Vietnam, Thailand, and Cambodia called for in the petitions abruptly froze solar supply chains. 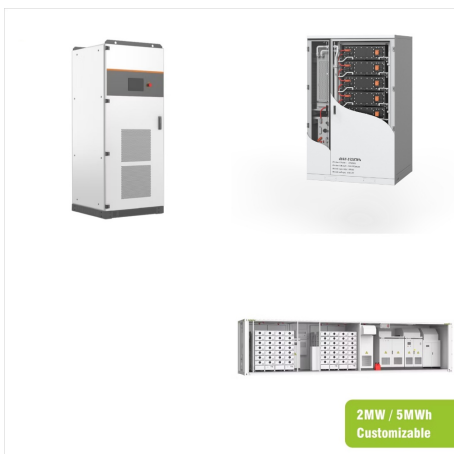

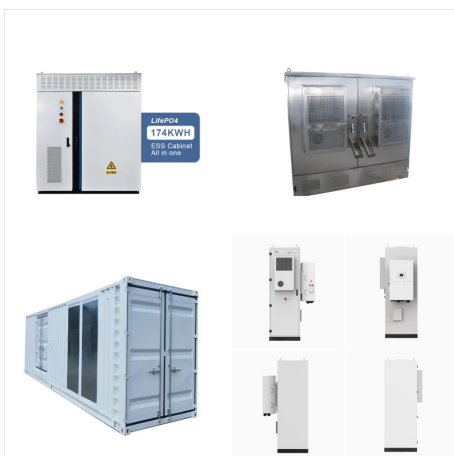
