



What is a solar energy system disclosure document?

Before your purchase, finance or lease of a residential solar energy system can be completed, your contractor must provide you with a "Solar Energy System Disclosure Document" cover page. The information in this document is meant to help give you accurate, clear, and concise information regarding the installation of the solar energy system.

Do I need a solar disclosure document?

YOU HAVE THE RIGHT to a Solar Disclosure Document from your solar provider. By law, a solar provider must provide a Solar Energy System Disclosure Document created by the CSLB and California Public Utilities Commission. This document provides you with information about your solar system, such as total costs.

What if a solar contract is not a disclosure document?

o The solar contract--not the Solar Energy System Disclosure Document--is the legally binding document between you and the Solar Provider. Make sure to read it carefully. o If you saw important information in the Solar Energy System Disclosure Document that is not referenced in the contract, ask the Solar Provider to include it.

What information should be included in a solar energy installation document?

The information in this document is meant to help give you accurate, clear, and concise information regarding the installation of the solar energy system. The document should help reduce misunderstandings between you and your contractor. Total cost for the solar energy system, including financing and energy/power costs if applicable;

What language should a solar energy system disclosure document be written in?

A contract for sale, financing, or lease of a solar energy system and this solar energy system disclosure document shall be written in the same language as was principally used in the oral sales presentation made to the consumer or the print or digital marketing material given to the consumer. BPC section 7169 Subdivision (d)

What are the governing documents for solar panels?

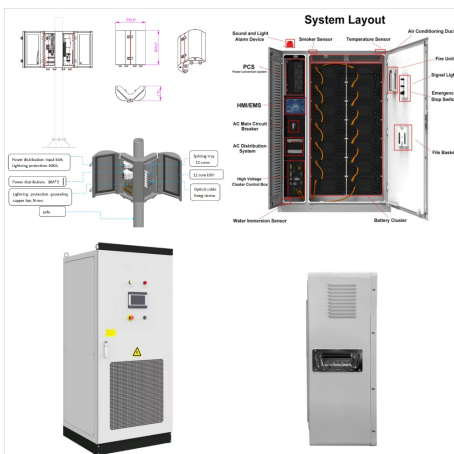

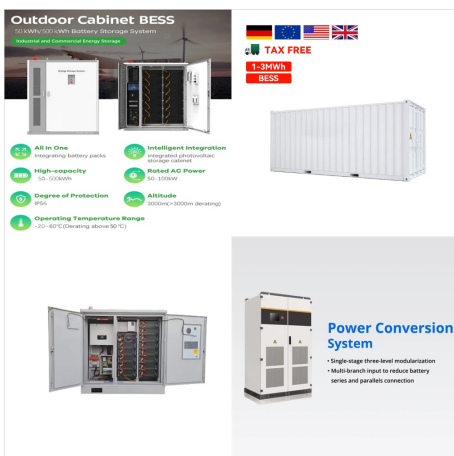

There are new requirements for solar energy system contractors as a result of Assembly Bill 1070 (Gonzalez Fletcher), Chapter 662, Statutes of 2017.. As of January 1, 2019, solar energy system companies must provide the Solar Energy System Disclosure Document to consumers printed in boldface 16-point font on either the front or cover page of every solar energy contract prior to ???

The Contractors State License Board is putting the industry on notice that a new Solar Energy System Disclosure document is go! What does that mean for those contractors installing residential solar systems? Assembly Bill 1070, Stats of 2017, Ch 662 established Business and Professions Code (BPC) section 7169. This new law requires the CSLB, in



Contractors must translate the document into other languages, as necessary. If the sale of the solar energy system utilizes Property Assessed Clean Energy (PACE) financing, the PACE Financing Estimate and Disclosure form may be used in place of the new disclosure document. The required elements of the PACE form can be found here.
