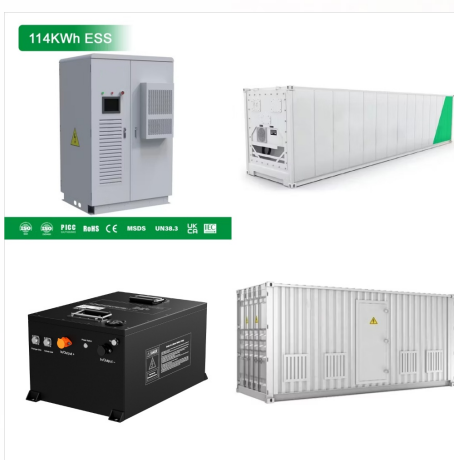

The cost of solar panels depends on many factors, but on Long Island the cost can be reduced by 55% by combining the 30% federal solar tax credit and the 25% state solar tax credit. For example, claiming these tax credits would reduce the net cost of a \$20,000 solar system to just \$9,000.



Highfield Solar will use the financing to build and operate the two solar PV plants, which will each have 141MWp of installed capacity. The Rosspile plant will be built on a 140ha site near Foulksmills, County Wexford, while the Gillinstown facility will be built on a 123ha site near Duleek, County Meath.

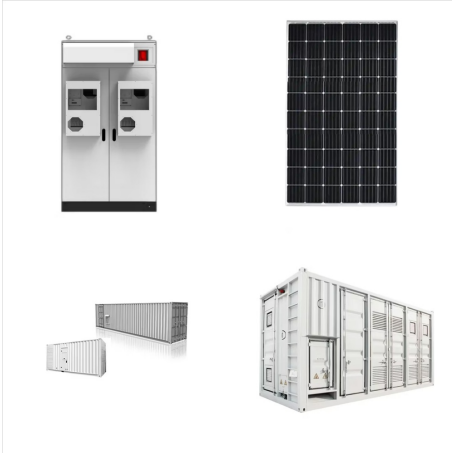

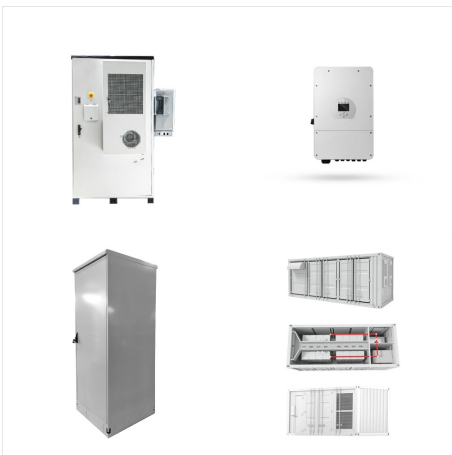
