

Will a solar power plant be built in Mineral County?

CHARLESTON, W.Va. (WBOY) -- A leading solar energy company has been approved to build a 100-megawatt solar power plant in Mineral County. The Public Service Commission of West Virginia (PSC) announced in a press release Wednesday that it has approved the plant and a battery storage facility along with it.

The Department of Energy is awarding \$90 million to a company that has promised to build what would be the largest solar project in the state on a former coal mine in central Pennsylvania. The 402-megawatt solar farm would be the largest in the state.
