

Are solar panels legal in Florida?

Florida law forbids ordinances, deed restrictions, covenants, or similar binding agreements from prohibiting solar equipment use.

Do I need to know Florida Statute 163 about solar panels?

If you live in a HOA governed community or serve on it's board, you should know Florida Statute 163 and what it says about HOA restrictions on solar panels.

Do you need a permit to install solar panels in Florida?

The inspection must be completed before the system is connected to the grid, and any necessary repairs or adjustments must be made before the system can be turned on. Another important aspect of Florida's solar laws is the process of obtaining a permit to install a solar panel system.

What is the Florida solar Rights Act?

The Florida Solar Rights Act ( Florida statute 163.04) protects the right of building owners to install solar panels. This Florida solar law prohibits homeowner associations and other groups from preventing the installation of solar panels on buildings in Florida.

Can HOAs install solar panels in Florida?

Does Florida tax on solar panels?

Since Florida state sales tax is 6%, the exemption on solar panels and equipment will save homeowners \$1,440 on an average \$24,000 solar panel installation. Florida is one of three states (along with California and Missouri) that allow property-assessed clean energy loans for solar panels.

Florida Solar Laws Title XI Section 163.04: Energy devices based on renewable resources. Florida state laws expressly forbid the prohibition of solar panels by local entities, including homeowners associations. Some rules regarding design and appearance may be allowed, for example, in historic districts.



(1) Notwithstanding any provision of this chapter or other provision of general or special law, the adoption of an ordinance by a governing body, as those terms are defined in this chapter, which prohibits or has the effect of prohibiting the installation of solar collectors, clotheslines, or other energy devices based on renewable resources is expressly prohibited.



In 2005, the Florida Legislature enacted a law allowing homeowners and businesses to install solar panels on their properties. The law took effect on August 5, 2008, and makes it authorized and permissible for taxpayers to ???
