How much is a solar energy credit?



The Energy Efficiency Improvement Tax Credit extends the Tax Credits on certain home upgrades to December 31, 2032. The Energy Efficiency Improvement Tax Credit was increased to 30 percent of the sum of Qualified Energy Efficiency Improvements and Residential or Qualified Energy Property Expenditures .





As of Nov 2024, the average cost of solar panels in Arizona is \$2.64 per watt making a typical 6000 watt (6 kW) solar system \$11,071 after claiming the 30% federal solar tax credit now available. This is lower than the average price of residential solar power systems across the United States which is currently \$3.00 per watt .



In 2012, the NREL determined that Arizona has the potential to install 5,147 GW of photovoltaic power plants, and/or up to 3,528 GW of concentrated solar power plants (CSP), sufficient to generate more than three times total US consumption in 2012.

This means that Tesla Solar Roofs and other solar tiles that act as solar panels and roofing qualify for the Solar Tax Credit. Non-solar roofs still do not qualify for the Tax Credit and Section 25D(e)(2) of the law makes this clear.

Note: The Renewable Energy Production tax credit is for a qualified energy generator that has at least 5 megawatts generating capacity and is not for a residential application. No preapproval is required for an individual income tax credit for a residential Solar Energy Device tax credit that is claimed on Form 310.





The IRS states in Questions 25 and 26 in its Q& A on Tax Credits that off-site solar panels or solar panels that are not directly on the taxpayer's home could still qualify for the residential federal solar tax credit under some circumstances.
