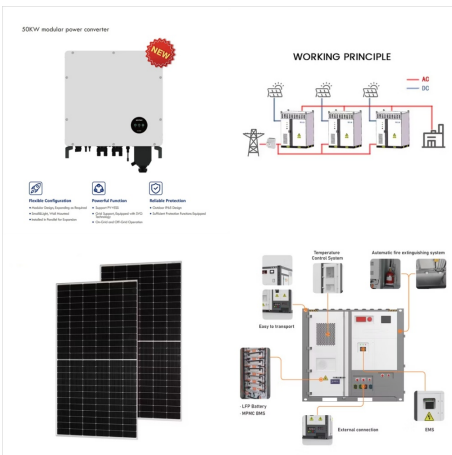

Property tax exemption: Florida's Property Tax Abatement for Renewable Energy Property program is extremely popular, as it waves the property tax increases typically associated with solar panel



The tax exemption program is open to both residential and commercial property. Qualifying equipment or system installations will entitle the property owner to a tax exemption for five years. The value of the tax exemption is based on the cost or a percentage of the cost of the installation and the solar equipment, facilities, or devices installed.

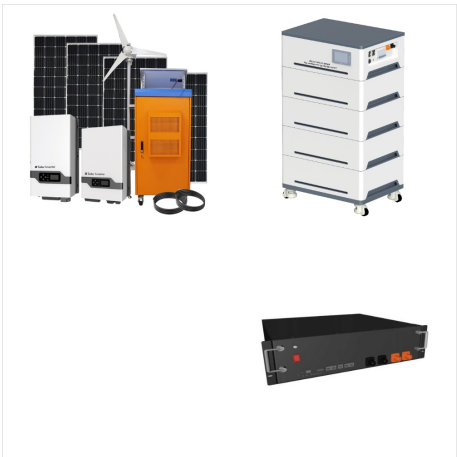


These items are exempt from the Nation Building Tax at the point of importation. Expenditure on Solar Panel Fixing: When filing Corporate Income Tax, there is a provision to declare the total expenditure on the acquisition of solar panels. This is entered in Cage 515 of the tax form as detailed in the "How to file CIT" guide.

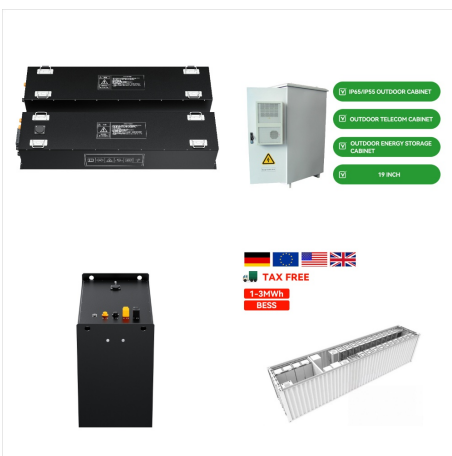

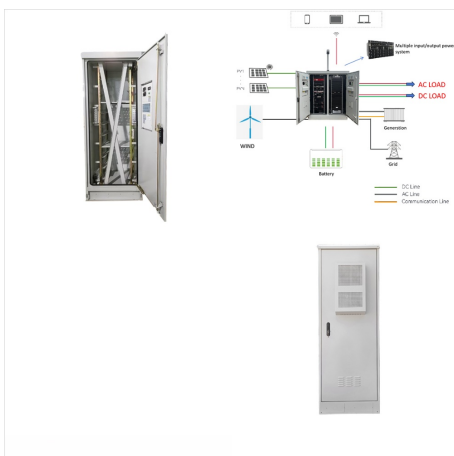

It provides for a seventy percent (70%) income tax exemption of the statutory income of the company for the year of assessment for applications received by MIDA from 1st January 2020.
