All the applicants can click at the respective links of their state to open the state electricity dept or power corporation website where Solar Rooftop online application / registration form is available. Ministry of New and Renewable Energy has directed to simplify the solar rooftop scheme.

How to install solar panels for free in India?

There is no government scheme for installing solar panels for free in India. However, the government announced the Rooftop Solar Scheme or the PM Surya Ghar Muft Bijli Yojana, which aims to install solar panels in houses and achieve solar energy generation and usage in households.

What is solar subsidy scheme in India?

The scheme is expected to benefit 1 crore households across India. It is estimated that the scheme will save the government Rs. 75,000 crore per year in electricity costs.
