

There are about fourteenof-grid energy companies in South Sudan, and their services include i) selling solar products, ii) engineer-ing, procurement, and construction (EPC), iii) independent power production (IPPs) and iv) developing mini-grids.

What is South Sudan's role as a power utility?

Its role as a power utility is expected to intensify as programmes to increase electricity access in South Sudan are implemented. It is proposed under the Electricity Bill 2015 as the regulatory entity for the electricity sector in South Sudan. It would function as the energy regulator whose functions would include the creation of regulations.

What is the governance of the energy sector in South Sudan?

The institutional and regulatory governance of the of-grid energy sector in South Sudan is still nascent. Table 2 below lists the major players participating in the governance of the energy industry and their positions as defined by applicable laws.

How much power does South Sudan need?

Meanwhile, with an installed capacity of approximately 130 MW, the majority of which is used to supply power to the country's extensive oil fields, South Sudan is currently evaluating ways to meet its power demand of 300 MWby way of renewable energy prospects.

Does South Sudan have a solar PV market?

The solar PV market in South Sudan is growing steadily, but minimal information is available.

Additionally, most companies operating in the country within the value chain do not have an online presence.

As such, the study mainly relied on primary information collected from the companies with which key informant interviews were conducted.

Are South Sudan & Ethiopia collaborating on regional energy cooperation?

Following a meeting between a delegation from South Sudan's Ministry of Energy and Dams,led by H.E. Minister Peter Marcello and state-owned electric producer, Ethiopian Electric Power, the two countries formally



targeted regional energy cooperation, with specifics outlined in a Memorandum of Understanding (MoU).
