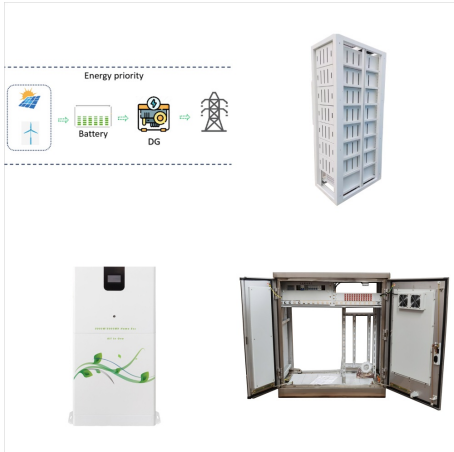

The cost of solar in Southern California. The average cost of solar in California is about \$3 per watt of electricity generation for a typical home system. To offset all their needs, a homeowner living in Southern California with an average monthly bill of \$200 would need a solar installation capable of generating 4.6 kilowatts (kW) under full sun.

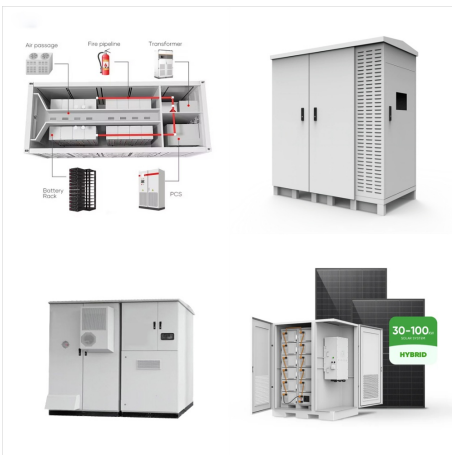
