St Kitts and Nevis does not have a universal healthcare system or a national health insurance scheme. However, St Kitts and Nevis passport holders under 18 and over 62 are entitled to free healthcare. While basic, primary healthcare is subsidized by the government and comes at a relatively low cost for those outside of those age groups.



The islands of St. Kitts (168 km 2) and Nevis (93 km 2) are located in the Lesser Antilles chain of islands in the eastern Caribbean. They are separated by a channel of just over three kilometres. The islands were inhabited first by the Sibonay who arrived approximately 2000 years ago from Central America.
