

Did Sterlite power raise Rs 725 crore?

NEW DELHI: Sterlite Power on Monday said it has raised Rs 725 crore in a primary fundraising round from GEF Capital Partners and ENAM Holdings. As part of Sterlite Power's demerger exercise, the Global Products and Solutions (GPS) business was hived out as an independent company in October 2024, a company statement said.

Does Sterlite have a power business?

The demerged Sterlite Power Transmission will now conduct the power capital goods business, comprising cables, conductors and specialised services, and the Sterlite Grid 5 Limited business will house the transmission concessions business, according to the release.

What does Sterlite power do?

Sterlite Power offers specialised Engineering, Procurement, and Construction (EPC) services aimed at expanding transmission capacity through uprating and upgrading existing infrastructure. Leveraging its expertise in complex project execution, the company delivers efficient, high-quality infrastructure solutions.

Why did Sterlite power raise funds?

The company aims to use the funds to boost its production capacity, new product development, and expansion in international markets, it said in a press release on Monday. Sterlite Power raised the funds from US-based GEF Capital Partners and Mumbai-based private equity firm ENAM Holdings.

Is Sterlite grid 5 a good investment?

The transmission business, now under Sterlite Grid 5 Ltd, can appeal to long-term investors looking for stable cash flows. Meanwhile, SPTL, focusing on its Global Products & Services (GPS) division, can attract investors seeking higher returns, often those interested in pre-IPO or capital market opportunities.
