



What happened to Sullivan Solar Power?

Sullivan Solar Power, a mainstay in the San Diego rooftop solar business since 2004, abruptly closed its doors in October. About a month later, the company's CEO and founder, Daniel Sullivan, was arrested by U.S. Marshals on charges of stalking an ex-girlfriend.

Are Sullivan solar power customers worried about liens & warranties?

Some Sullivan Solar Power customers are worried about liens and warranties since the company has locked its doors and is not returning phone calls. Sullivan Solar Power is one of the largest solar installation companies in the San Diego area.

Is Sullivan solar going out of business?

As of Friday, there are no records of Sullivan Solar Power filing for bankruptcy but there are complaints of uncompleted projects and financial difficulties. Rooftop solar installations cost well into the tens of thousands of dollars and Sullivan Solar's abrupt closure has left many customers irate.

Does Sullivan Solar have a bond company?

According to Jesse Raymond, a contractor, those victimized by Sullivan Solar should check the Contractor's State Licensing Board website for the bond company listed for Sullivan Solar. The bond company is Platte River Insurance Company in Madison, Wisconsin, which can be contacted at (800) 475-4450.

What happened to Sullivan Solar in El Cajon?

Sullivan Solar, one of the largest and most well-known rooftop solar installers in the San Diego area, suddenly closed its doors two months ago in El Cajon, leaving some of its customers in the lurch. An electrician checks on a solar rooftop array and battery installation in El Cajon.

Did Sullivan Solar hire a subcontractor?

Sullivan Solar hired a subcontractor who has not been paid by Sullivan, leaving the homeowner potentially exposed to a \$6,000 lien on his property. The subcontractor, according to Cornillez-Ty, has not received payment from Sullivan. 'I can't blame the subcontractor because they have to be paid,' Cornillez-Ty said. 'I've tried calling (Sullivan Solar) and nobody responded.'

Court records for San Diego County show litigation against Sullivan Solar Power filed by Capital One Bank, First Insurance Funding, and Proven Solutions, LLC. Dan Sullivan is similarly facing a lawsuit from Proform Interior Construction Inc.
