The Laos government signed a concession agreement with CGN Laos Taven Power Sole Co., Ltd. for the construction of Phase I of a 1,000 megawatt (MW) solar farm in the northern districts of Xay and Namor, Oudomxay province. This project is a step in advancing renewable energy efforts for both Laos and China.





A signing ceremony was held yesterday for the development of a floating solar power plant on the surface of the Nam Ngum 1 dam reservoir. 



The construction of the proposed solar farm will take place in three stages over 10 years. In 2020, Laos also signed a Project Development Agreement (PDA) with China's Hangzhou Safefound Technology Company to develop a floating solar power project at Nam Ngum 1, with an installed capacity of up to 1,200 MW on an area of more than 1,500 ha.



The project is being developed and currently owned by Convalt Energy and Viet Lao Power Joint Stock. The owners have 50% stake in the project respectively. Convalt Energy-Attapeu Solar PV Park is a ground-mounted solar project which is planned over 850 acres. The solar power project consists of 460,000 modules. Development status



The Laos government has signed a new concession agreement with CGN Laos Taven Power Sole Company Limited, part of China's state-owned China General Nuclear (CGN) Group arm CGN Energy International Holdings Company Limited, for the construction of Phase I of a 1,000 MW solar farm in Xay and Namor districts, Oudomxay province, northwest Laos.
