

Why did Technip acquire PEMEX Refinaci&#243;n?

Emiliano Pescador, Technip's Country Manager in Mexico, stated: " This is our first EPC contract awarded by PEMEX Refinaci&#243;n. We managed to capture it thanks to the acquisition of Stone & Webster process technologies and associated oil and gas engineering capabilities and its extensive experience and state-of-the-art technology portfolio.

Is TechnipFMC a good stock to buy?

It operates through three business segments -- Subsea, Surface Technologies and Technip Energies. The company's shares have underperformed the industry in the past six months. Its shares have gained 16.9% compared with the industry's 24.4% growth. TechnipFMC currently carries a Zack Rank #4 (Sell).

How many countries does Technip operate in?

Present in 48 countries, Technip has state-of-the-art industrial assets on all continents and operates a fleet of specialized vessels for pipeline installation and subsea construction. Technip shares are listed on the NYSE Euronext Paris exchange and the USA over-the-counter (OTC) market as an American Depositary Receipt (ADR: TKPPY).
