Ltd., Estrella Resources Ltd. and Beacon Minerals Ltd., plus local group Peak Everest Mining Lda, were granted a total of 13 concession areas by regulator Autoridade Nacional dos Minerais (ANM) at an event in Dili, Timor-Leste. Six companies had applied for exploration tenements.

How many companies have applied for mineral tenements in Timor-Leste?

Last month, the IX Government of Timor-Leste, through the Ministry of Petroleum and Minerals (MPM) announced nine mining companies are eligible to compete in the Timor-Leste Minerals Tender 2023. "Out of the 49 concession areas opened for tender process, thirteen (13) concession areas are awarded to the four successful bidders.

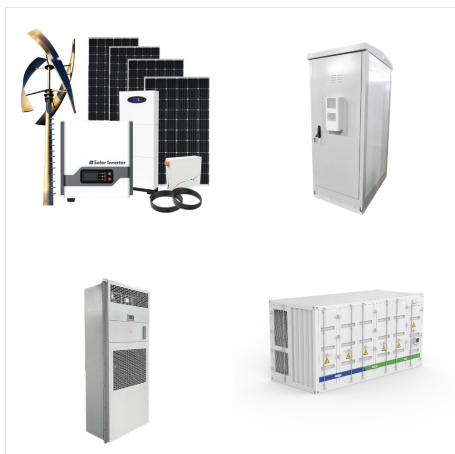

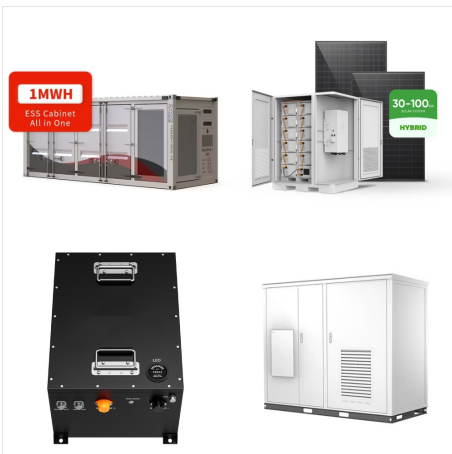
