



What does the European Union do for Turkmenistan?

The European Union is dedicated to supporting Turkmenistan's efforts to transition towards a more sustainable, green economy while simultaneously enhancing its business environment.

Can Turkmenistan export gas to the west?

This agreement signifies the EU's first formal support of Turkmenistan's ambition to export its substantial gas reserves to the West. This deal signifies Turkmenistan's newfound openness to supply Western markets. However, if Turkmenistan wishes to continue supplying Europe with its vast gas reserves, it must upgrade its Westward export capacity.

Does Turkmenistan have a green economy?

Turkmenistan, home to the world's fourth-largest reserves of natural gas, has traditionally been dependent on its extractive industry for economic growth. However, there has been a notable shift in the country's economic strategy towards embracing a greener and more diversified economy.

How can the EU improve transport connectivity with Turkmenistan?

The EU is deeply committed to strengthening its engagement for improving transport connectivity along the Trans-Caspian Corridor with Central Asia, including with Turkmenistan, following the recommendations of the Study on Sustainable Transport Connections between Europe and Central Asia.

Will Hungarian-Turkmenistan gas be sent to Iran?

While Hungary's Minister of Foreign Affairs, Peter Szijjarto, didn't disclose specific details of the Hungarian-Turkmenistan gas talks, it's anticipated that Turkmenistan will dispatch modest quantities, potentially up to 1 billion cubic meters annually, to Iran through existing pipelines.

How is Turkmenistan integrating into the global economy?

Additionally, Turkmenistan has taken a significant step towards integrating into the global economy by expressing its intent to join the multilateral trading system. In February 2022, Turkmenistan achieved the status of an acceding country to the World Trade Organisation (WTO).

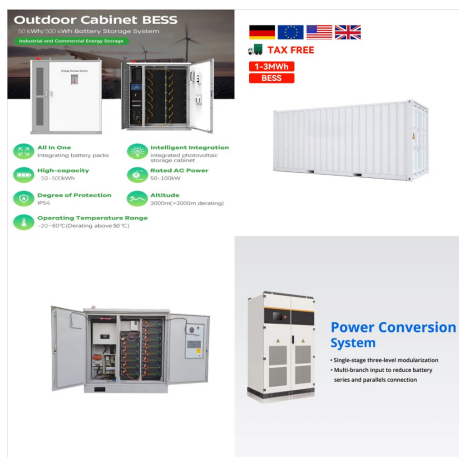

Efforts to bring Turkmenistan's natural gas to Turkey predate the December 1997 Gazprom-led and promptly operationalized Blue Stream project. The Russians, strong in both the European and Turkish markets, didn't want cheaper, competitive Turkmen gas to arrive, so they thwarted a series of initiatives in partnership with Iran.

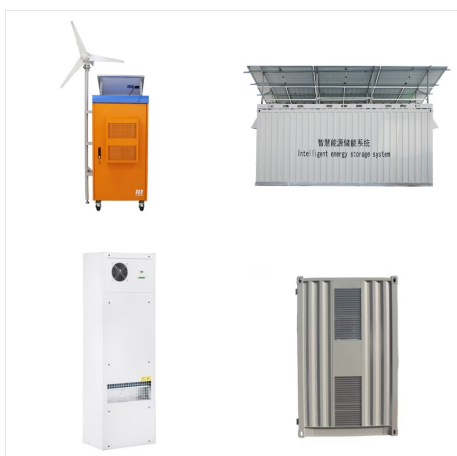

Europe's reliance on this energy partnership, while maintaining sanctions against Iran, creates a paradoxical strategic distancing, allowing Europe to benefit while maintaining a symbolic separation from Iran. Turkmenistan's gas exports peaked in 2008 and have not reached those levels since. Despite being a landlocked nation, already existing export infrastructure capacity (124.5 bcma) by far exceeds Turkmenistan's natural gas exports. Even the route leading to Turkmenistan's most lucrative export market (China) remains partially idle.



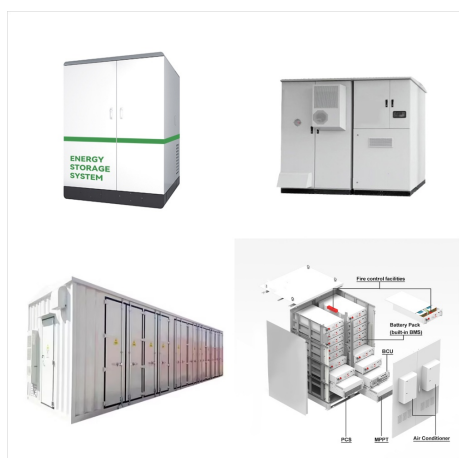
