Why is Vista a safe Oil & Gas Company?

As a company committed to delivering reliable, affordable, and lower carbon oil and gas, Vista acknowledges that spill incidents pose significant environmental risks associated with our operations. We actively manage, assess, and enhance preventive measures and controls.

How much did Vista invest in 2023?

In 2023,our carbon footprint reduction plan comprised 5 projects and an investment of 4.0 \$MMwith a positive IRR (internal rate of return) at an internal carbon price of 50 \$/tnCO₂e. The amount invested in 2023 represented less than 0.5% of total Vista's annual capital expenditure.

Is Vista a good Vaca Muerta well?

As of December 31,2023,the Vista average well (representing the average of our pads BPO-1 to BPO-10) was performing 6% above our Bajada del Palo Oeste type curve after 720 days of production. This productivity performance places our wells among the best of Vaca Muerta.

What policies did Vista offer in 2023?

During 2023, we offered training to 100% of our staff on the contents of our new Code of Ethics and Vista's Integrity Compliance Program. During 2023 we also published 5 additional policies on our website: Human Rights, Conflicts of Interest, Anti-corruption, Anti-harassment, and Diversity, Equity & Inclusion.






