Fulcrum recently announced the successful production of low-carbon synthetic crude oil from landfill waste at

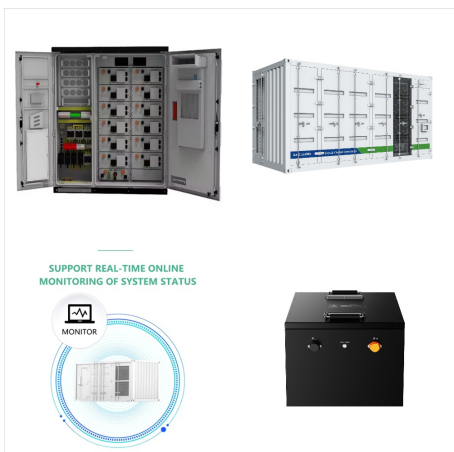
its Sierra BioFuels Plant, the world's first commercial-scale waste-to-fuels plant, located outside of Reno, Nevada in the U.S.

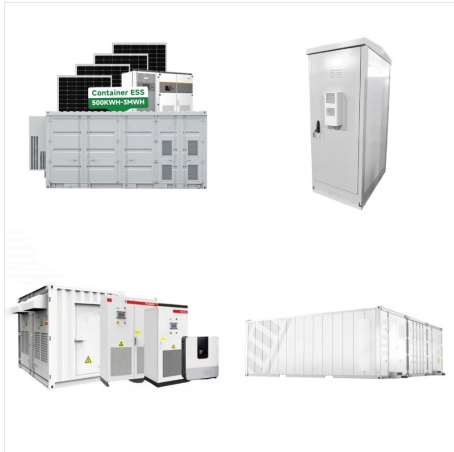

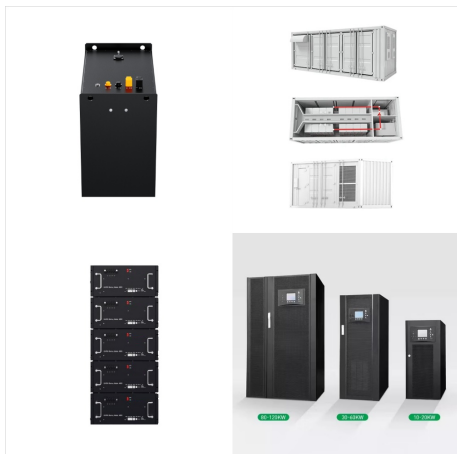

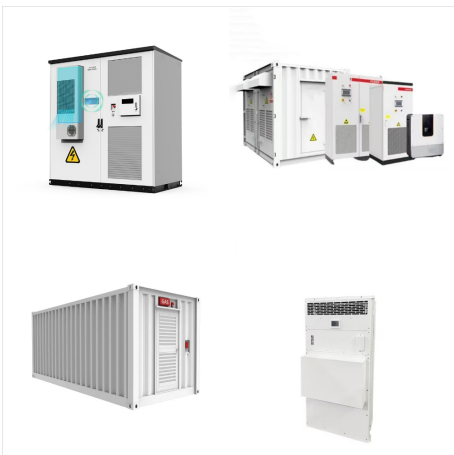
