

FRV Australia and its joint venture partner, Genesis Energy, have begun the construction of the largest solar farm in New Zealand after reaching financial close in December 2023. The 63 MWsolar farm, once operational by the end of 2024, will power the equivalent of nearly 13,000 houses.


