



VRET houses renewable energy projects in India. It has a portfolio of ~538 MWp and is acquiring an additional project of 25 MWp. The units were listed on the National Stock Exchang e in October 2021. Virescent Infrastructure Investment Manager Pvt Ltd (VIIMPL) is a renewable energy platform backed by KKR and incorporated in August 2020.





"India Grid Trust (IndiGrid) has completed the acquisition of 100 per cent units of Virescent Renewable Energy Trust on August 25," it said in a BSE filing. VRET is a Sebi-registered infrastructure investment trust set up on February 25, 2021 as per provisions of the InvIT Regulations.
