The LNG supply to Vitol Asia will commence in 2024, with about 550,000 tonnes per annum for a period of three years on a Free on Board basis, with a possible one-year extension, Vitol said in a statement.

In 2013, Vitol invested in its first power plant, VPI Immingham in the UK. The combined heat and power plant (CHP) is one of the largest of its kind in Europe, capable of generating 1,240 MW and up to 930 tonnes of steam per hour which is used by nearby refineries.
